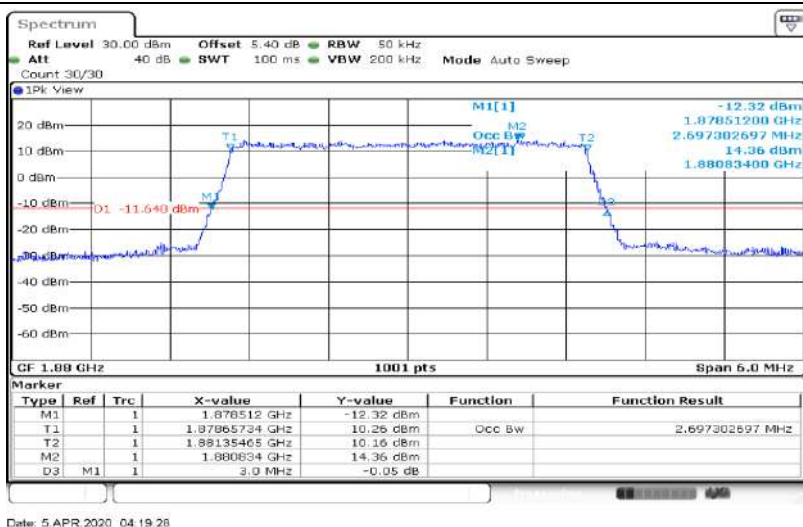


Band2-3MHz-QPSK-18615-15RB#0-2.697

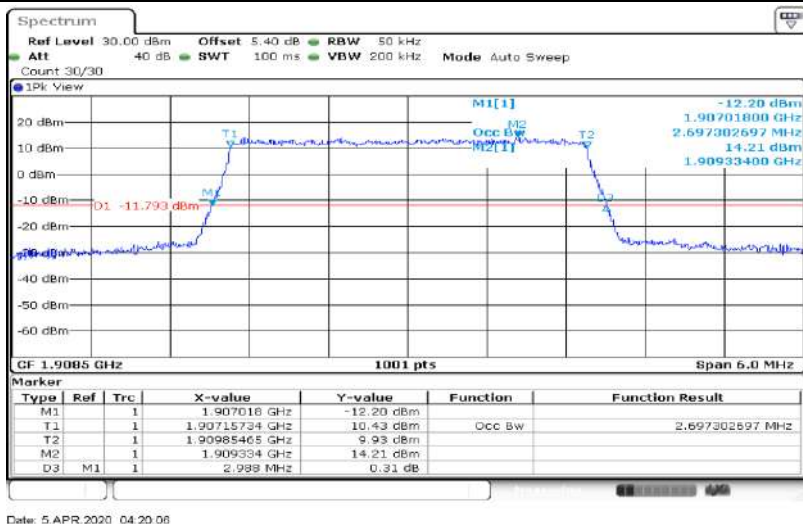


Band2-3MHz-QPSK-18900-15RB#0-2.697



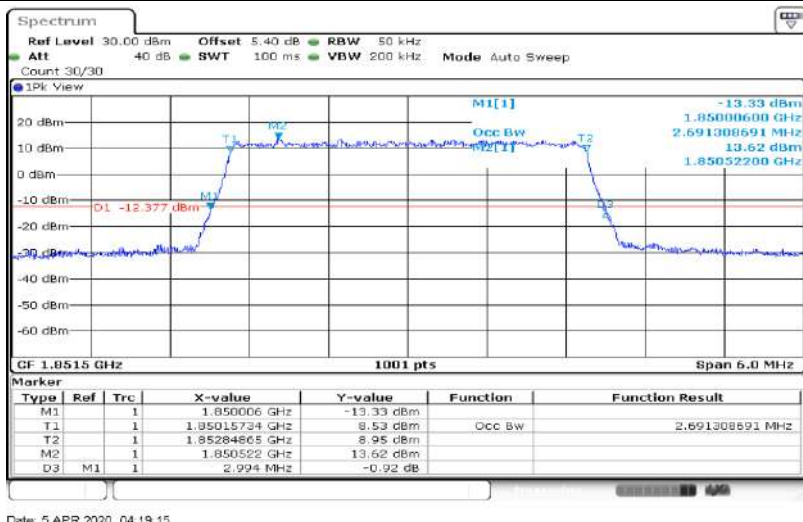

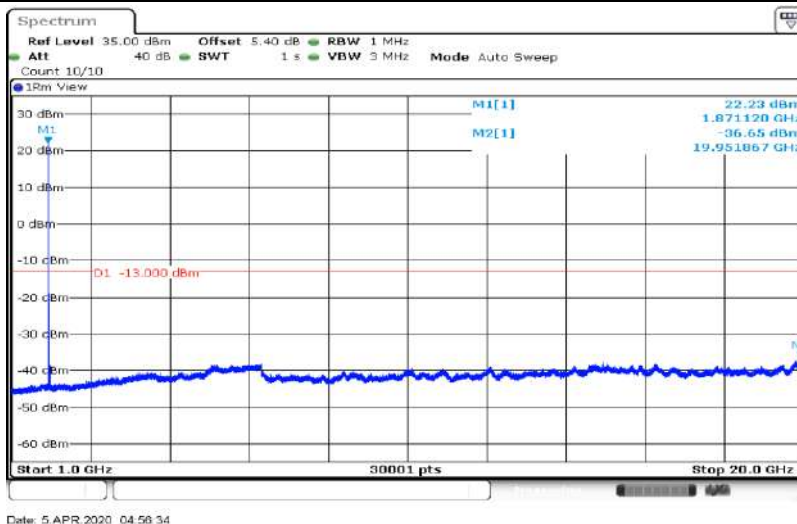


Band2-20MHz-QPSK-18900-1RB#0-Range1:30~1000MHz



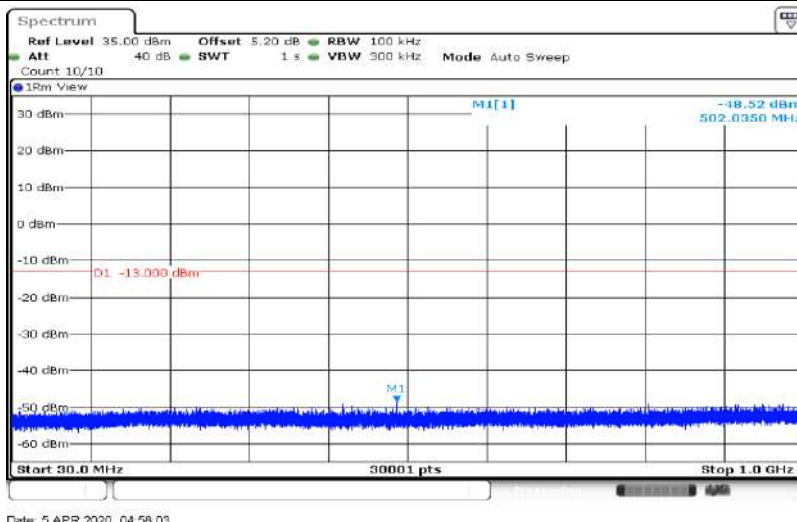

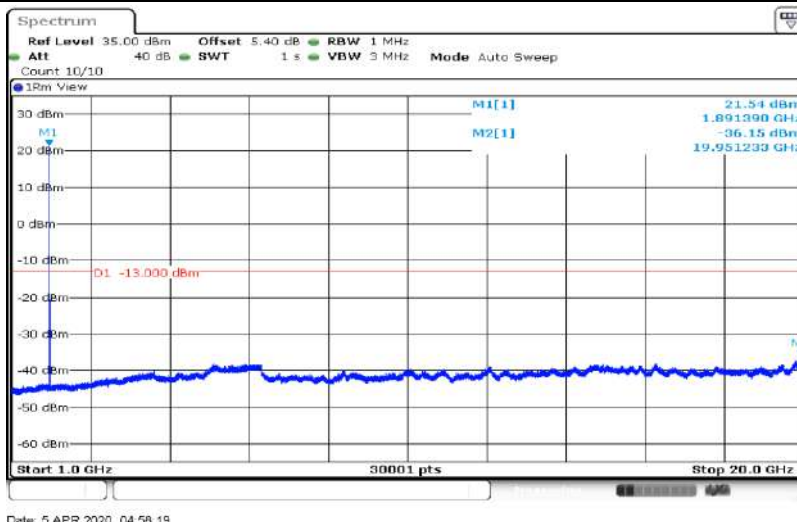


Band2-20MHz-QPSK-19100-1RB#0-Range1:30~1000MHz

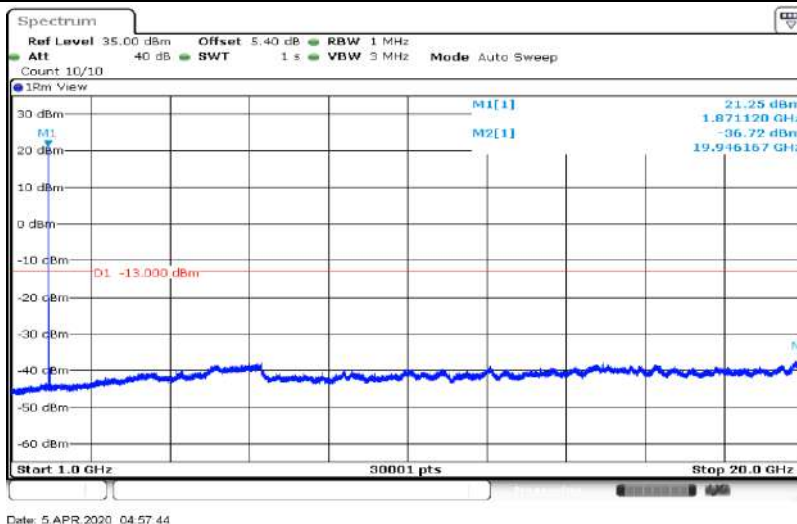


Band2-20MHz-64QAM-18900-1RB#0-Range1:30~1000MHz



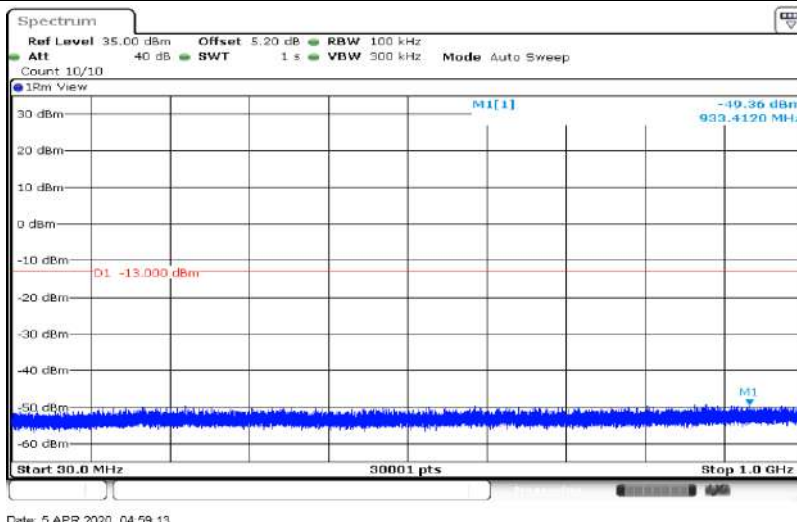


Band2-20MHz-64QAM-18900-1RB#0-Range2:1000~20000MHz

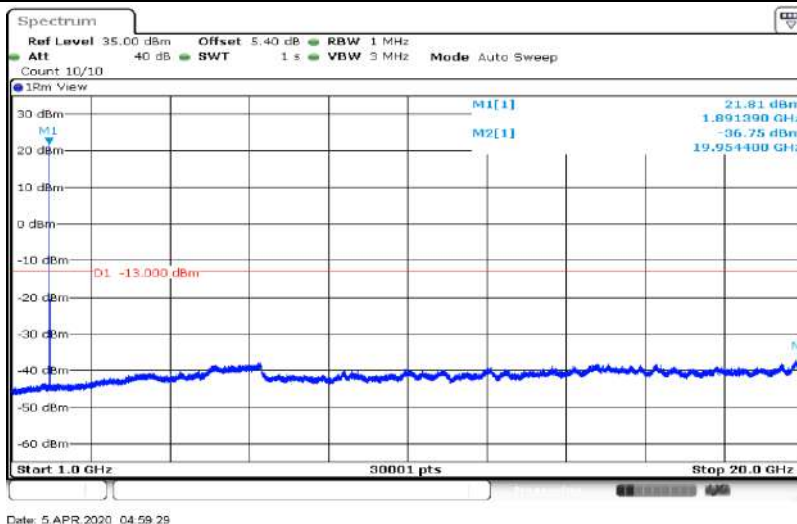


Band2-20MHz-64QAM-19100-1RB#0-Range1:30~1000MHz



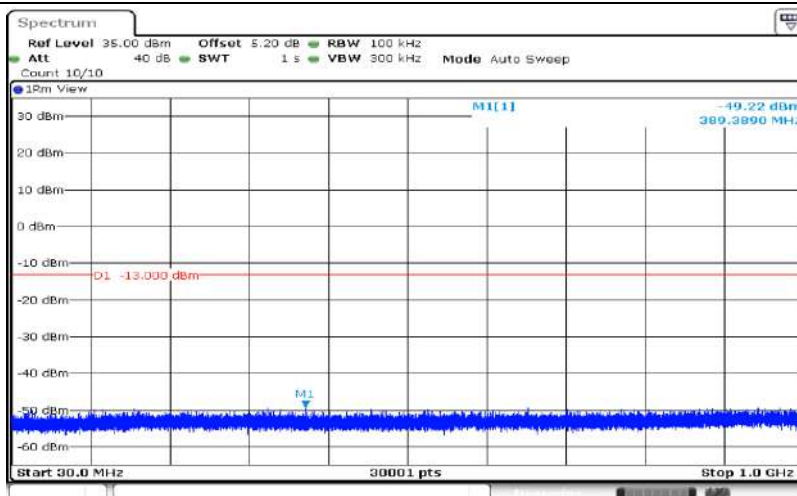
