




LTE band 41

NOTE: peak above the limit line is the carrier frequency.




LTE band 66

NOTE: peak above the limit line is the carrier frequency.








LTE CA band 7C

A.8 Peak-to-Average Power Ratio

The peak-to-average ratio (PAR) of the transmission may not exceed 13 dB

- Refer to instrument's analyzer instruction manual for details on how to use the power statistics/CCDF function;
- Set resolution/measurement bandwidth \geq signal's occupied bandwidth;
- Set the number of counts to a value that stabilizes the measured CCDF curve;
- Record the maximum PAPR level associated with a probability of 0.1%.
