
### Pairing iPad™ Case with Bluetooth Keyboard with iPad™

Preparation: Please make sure both your iPad and iPad case with bluetooth keyboard are fully charged prior to proceeding (for first use please charge it with supplied USB cable for at least 3 hours).


**Please note: If you're experiencing a "lag" while typing, this is a sign that your battery level is low and must be recharged.**

Lights:

Step 1: Toggle on the **Power Switch**, the **Power and Bluetooth Indicators** should be lit for approximately 5 seconds. It is now in idle mode. Now press the **Connect Button**. With the **Power Indicator** lit, the **Bluetooth Indicator** should be flashing. It is now in pairing mode.



Step 2: On the iPad, tap **Settings**. Within the **General** tab, select **Bluetooth**. If Bluetooth is turned off by default, swipe to turn it on. The iPad should now be searching for all Bluetooth devices within range. Wait for **Bluetooth Wireless Keyboard** to appear under **Devices**.


Step 3: Tap on **Bluetooth Wireless Keyboard** to connect. It is required to type in the 4-digit code according to the on-screen instruction. Hit enter, it should now be connected.

### Using the Keyboard

Using some of the function keys at the top to go to the Home screen, open Spotlight, adjust the brightness of your screen, control the sound volume, and much more.



- Go to the Home screen, which contains your applications.
- Increase, decrease, or mute the sound volume coming from the iPad.
- Fast-forward, Play (Pause), or Rewind your multimedia.
- Search for almost anything, including pictures, music, messages and contacts.
- Show and hide the onscreen keyboard
- Copy (+C), cut (+X), paste (+V), select-all (+A) are supported by the iPad.
- Special characters are available in conjunction with other letter and number keys.
