

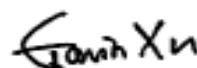

2.1.2 Calculation formula:

Prediction of power density at the distance of the applicable MPE limit

$S = PG/4\pi R^2$ = power density (in appropriate units, e.g. mW/cm²);

P = power input to the antenna (in appropriate units, e.g., mW);

G = power gain of the antenna in the direction of interest relative to an isotropic radiator, the power gain factor, is normally numeric gain;

R = distance to the center of radiation of the antenna (appropriate units, e.g., cm);

For simultaneously transmit system, the calculated power density should comply with:

$$\sum_i \frac{S_i}{S_{Limit,i}} \leq 1$$

Simultaneous transmission:

The WLAN 2.4G and 5G can't transmit simultaneously, but 2.4G Wifi or 5G Wifi can transmit simultaneously with 2 Radars:

Result: Compliant. The device compliant Simultaneous transmission at 20cm distances.
