Alco RF OBC Dock



Introduction

Use this Guide to assist with set-up and operation of Alco RF OBC (On Body Charger) Dock. The Alco RF OBC Dock is intended to be paired with the Alco Tag; the Alco Tag will report in RF mode when the Alco RF OBC Dock is detected.

The Alco RF OBC Dock is also used to charge Alco OBCs.


* The Alco RF OBC Dock has attachments suitable for regional applications

Set-up Alco RF OBC Dock

Make sure Alco RF OBC Dock is ready for operation and tested for communication response before instalment.

!Info *Alco RF OBC Dock will be in passive mode and pre-assigned to a wearer profile - refer to the Eagle User Guides*

Charge Alco OBC





Plug Alco RF OBC Dock into a mains socket

!Info

The Alco RF OBC Dock should not be installed in a position which is exposed to high temperatures, such as an open flame or heat-emitting equipment

- The Alco RF OBC Dock should be plugged into a fixed socket in the residence of the wearer of the paired device
- To avoid signal interference do not place the Alco RF OBC Dock on or near appliances that emit radiowaves, E.g., television, microwave, VCR
- Reposition the Alco RF OBC Dock location to increase the separation distance between the device and receiver if there is interference to a nearby appliance signal





Pair Alco Tag to Alco RF OBC Dock

!Info

Refer to the Eagle User Guides for remote alert and wearer profile actions

- The Alco Tag makes a wireless connection to the Alco RF OBC Dock when the devices are detected in proximity

**C**

Charge the Alco OBC using the Alco RF OBC Dock

!Info


Inform the wearer how to charge the device and if fitted device wearer alerts are active

4 hours (approximately) is the time required to fully charge the Alco OBC

- Place the Alco OBC onto the dock to charge - the Alco OBC LED will indicate when it is fully charged

LED	Alco RF OBC Dock State Indication
GREEN (Fast flash)	Alco OBC is charging
GREEN (solid continuous)	Alco OBC is fully charged
GREEN (Blinking)	Alco OBC is ready to charge the Alco Tag (Alco OBC not on dock)

Decommission Alco RF OBC Dock

Remove Alco RF OBC Dock

!Info

The Alco RF OBC Dock should not be immersed in water during cleaning

Inspection should include physical checks for tamper or damage to the pins

- Disconnect the Alco RF OBC Dock from the mains socket
- Follow the recommended inspection and cleaning procedures
