



## Bluetooth® Headset

Please read this user's guide before using your new headset.

### Charge Your Headset

When the headset beeps and the indicator flashes red, charge your headset.

- Normal charging takes about one hour.
- Provides up to 5 hours of talk time and up to 168 hours standby.

1. Connect the supplied charging cable to the USB port of your computer and to the headset's micro USB charging port. The **Indicator** lights red when charging and turns off when fully charged.
2. Unplug the charging cable when the headset is fully charged.



### Pairing

1. Press and hold the **Multifunction** button for 7 seconds to enter pairing mode. A voice says "Pairing". The **Indicator** flashes red and blue as your headset searches for Bluetooth-enabled devices.
2. Follow the instructions for your Bluetooth-enabled device to pair with the headset. When paired, the **Indicator** flashes blue every 7 seconds and the headset enters standby mode.

3. To pair a second device, press and hold **Vol +** for 3 seconds to enter pairing mode. (The headset will disconnect the first Bluetooth device automatically.) Pair and connect with the second device, then manually connect the first device according to its pairing instructions.

**Note:** If your Bluetooth-enabled device(s) are out of connection range and disconnect, move back within 10 minutes to reconnect automatically.

### Using the Headset

To turn on the headset, press and hold the **Multifunction** button for 3 seconds. The **Indicator** flashes blue three times. A voice says "power on". See the following table to make and receive calls.

To turn off the headset, press and hold the **Multifunction** button for 3 seconds. The **Indicator** flashes red 3 times. A voice says "power off".

Make a call		Use your mobile device normally
Answer or end a call		Press briefly, or use the phone keys
Reject a call		Press and hold for 3 seconds
Redial the last called number	Multifunction	Press twice quickly
Toggle a call between your headset and your connected phone		Press and hold for 3 seconds
Mute or unmute during a call	Vol -	Press and hold for 3 seconds
Activate voice dial when no call is in progress		Press and hold for 3 seconds until the phone starts voice dialing
Answer a second call during a call	Vol +	Press and hold for 3 seconds
Switch calls between two paired phones		Press and hold for 3 seconds

### Listen to Music

- To play/pause: press the **Multifunction** button.
- To go to previous track: press and hold **Vol -** for 3 seconds.
- To go to next track: press and hold **Vol +** for 3 seconds.

**Note:** The button function may vary depending on your phone's protocol and devices.



## Changing Bluetooth Devices

Your headset automatically reconnects to the most recently paired device when it is powered on.

To pair a new device, you must disconnect the current device's Bluetooth functions first. See your Bluetooth device's instructions for details.

## Near Field Communication (NFC)

NFC allows you to connect or disconnect Bluetooth communication by touching your headset to your NFC-enabled device (back, top, or bottom).

To change NFC devices, touch the second device to the headset. The headset will automatically connect to the device and disconnect from the first device.
