b) User's manual may be held confidential only when the manual contains proprietary technical information intended for professional technicians obligated under a NDA. All sales and distribution of the user's manual must be under a NDA that restricts the disclosure of the information.

→ Kronegger GmbH only sells this product to business customers/system integrators – a NDA is mandatory.

Non Disclosure Agreement

The parties mentioned before intend to set up a closer relationship in developing and selling RFID products. In order to protect confidential information, the parties hereby agree as follows:
