Band12-1.4MHz-QPSK-23017-1RB#0-Range1:30~1000MHz



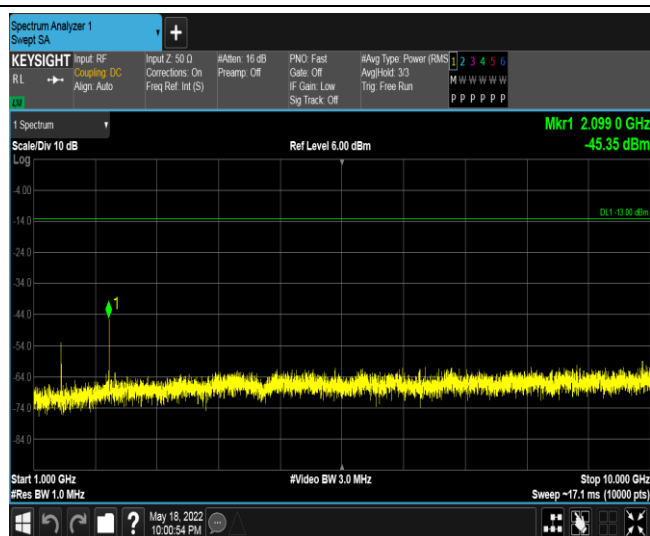
