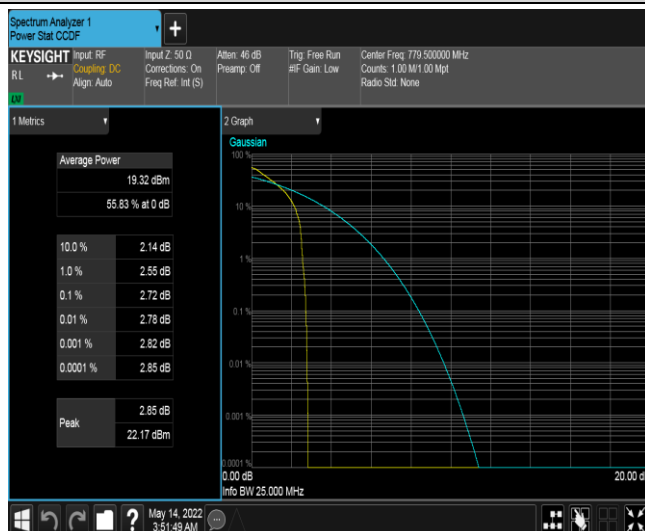

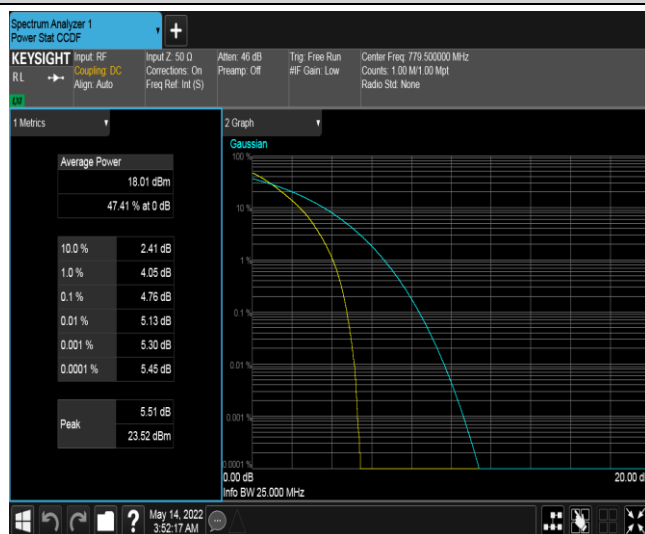

Band13-5MHz-QPSK-23205-25RB#0



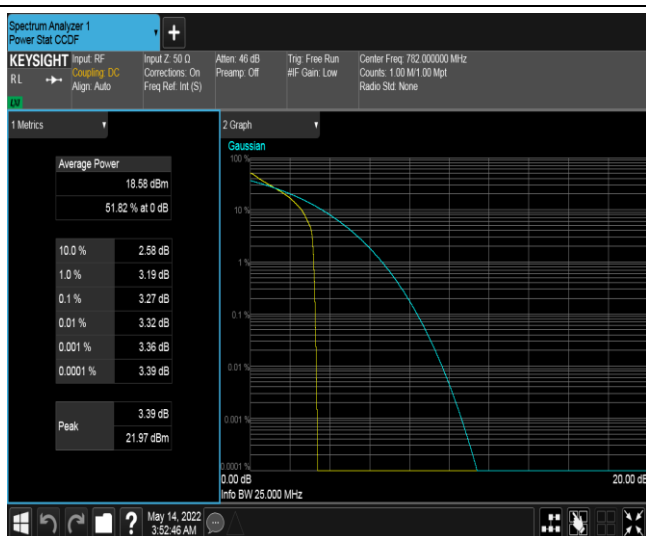
