Band25-1.4MHz-QPSK-26683-1RB#0-Range1:30~1000MHz

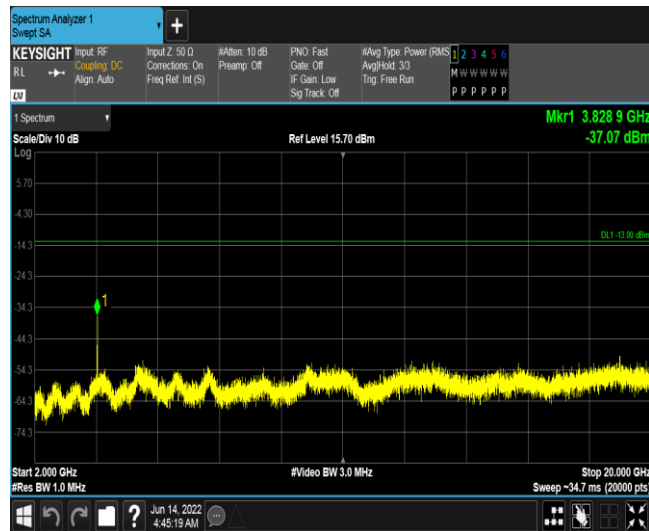
