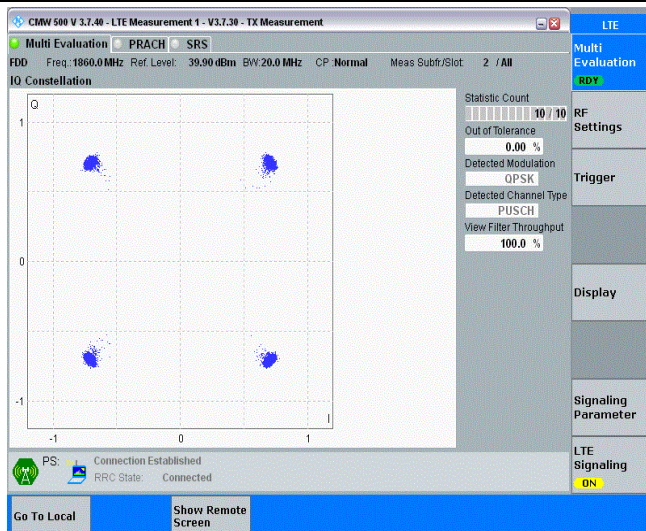

Band25-20MHz-QPSK-26365-100RB#0



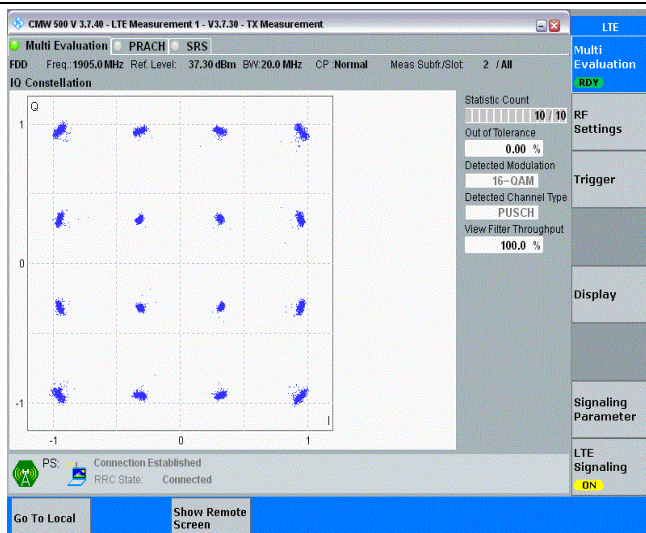
