













Photograph of the tissue simulant fluid liquid depth (Head)












Fig.3 EUT Back side to flat phantom






Fig.4 EUT Top side to flat phantom






Fig.7 EUT Left side to flat phantom






Fig.8 EUT Bottom side (Notebook mode) to flat phantom




Fig.11 Antenna location (Tablet mode)




Fig.12 Antenna location (Notebook mode)
