 - Add new vendor of Band 25 duplexer: Avago(Model: ACMD-6225)
 - Add new vendor of GNSS LNA: MAXSCEND(Model: MXDLN16TP)

Based on the similarity between two models, The differences have no influence on the test results, all the test results are leveraged from original report FA003022-02.

4. RF Exposure Limit Introduction

According to ANSI/IEEE C95.1-1992, the criteria listed in Table 1 shall be used to evaluate the environmental impact of human exposure to radio frequency (RF) radiation as specified in §1.1310.

The MPE was calculated at 20 cm to show compliance with the power density limit.

The following formula was used to calculate the Power Density:

$$S = \frac{PG}{4\pi R^2}$$

Where:

S = Power Density

P = Output Power at Antenna Terminals

G = Gain of Transmit Antenna (linear gain)

R = Distance from Transmitting Antenna
