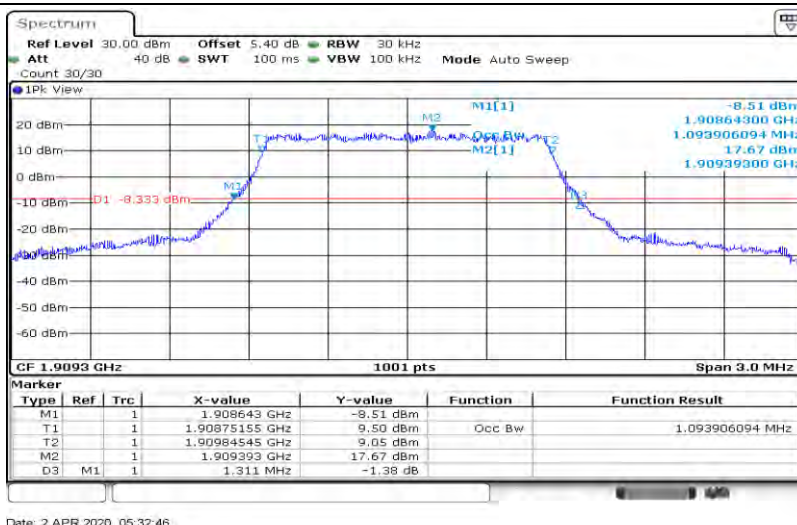

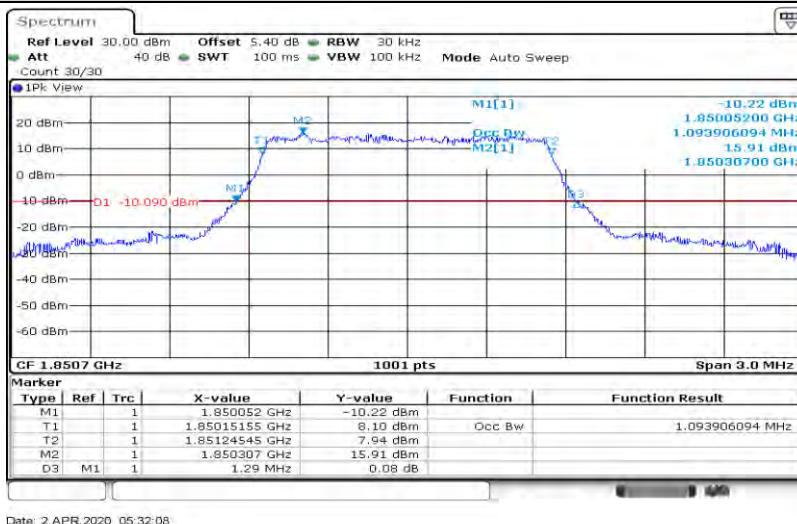


Band2-1.4MHz-QPSK-19193-6RB#0-1.094



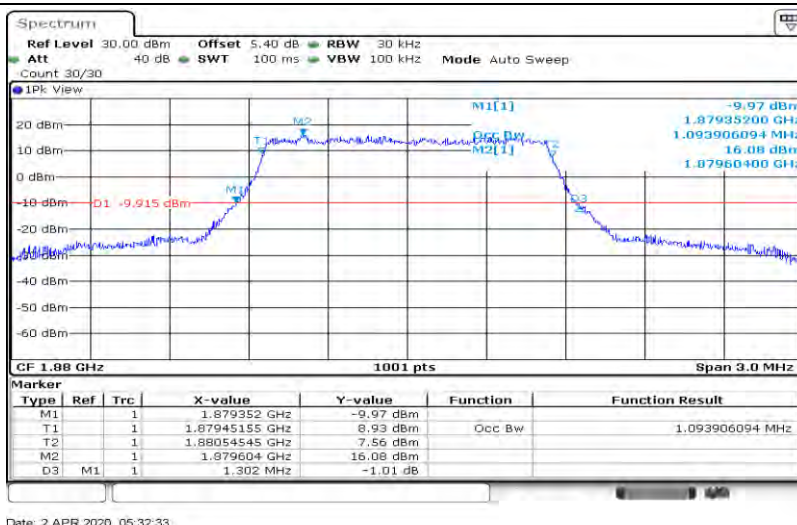


Band2-1.4MHz-16QAM-18607-6RB#0-1.094

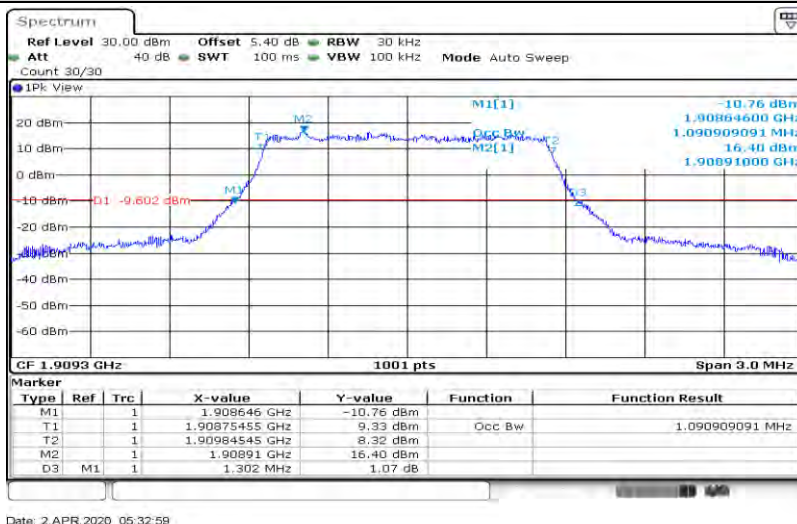


Band2-1.4MHz-16QAM-18900-6RB#0-1.094



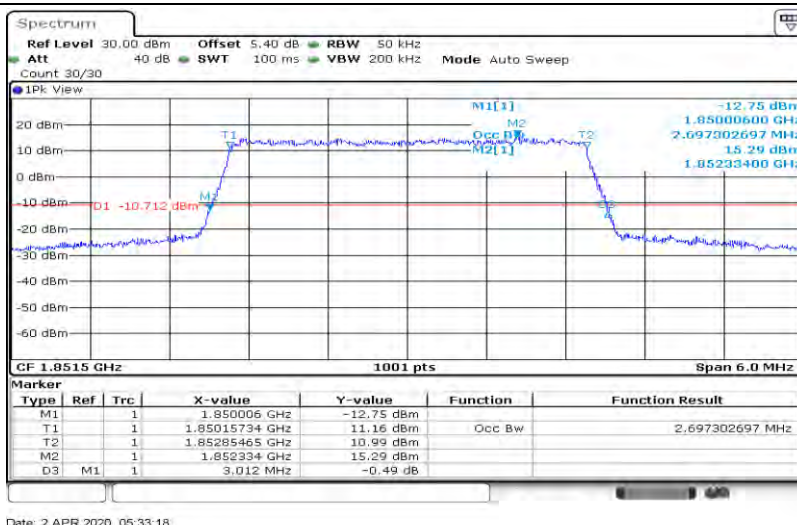


Band2-1.4MHz-16QAM-19193-6RB#0-1.091

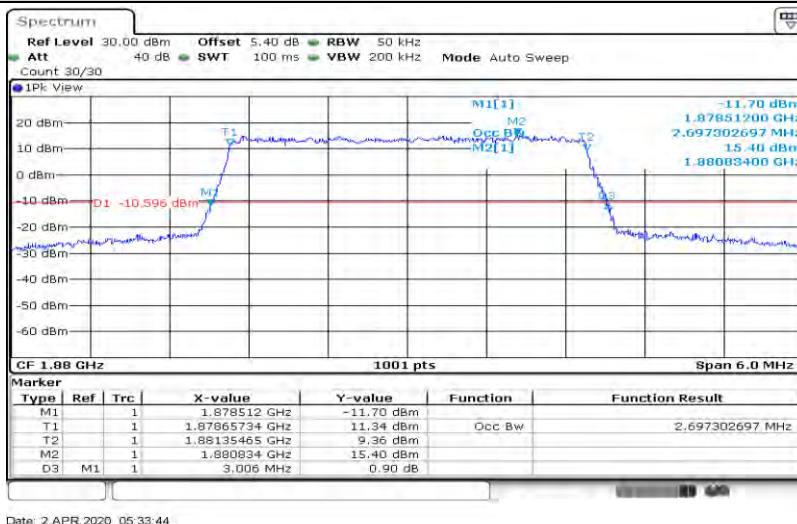


Band2-3MHz-QPSK-18615-15RB#0-2.697



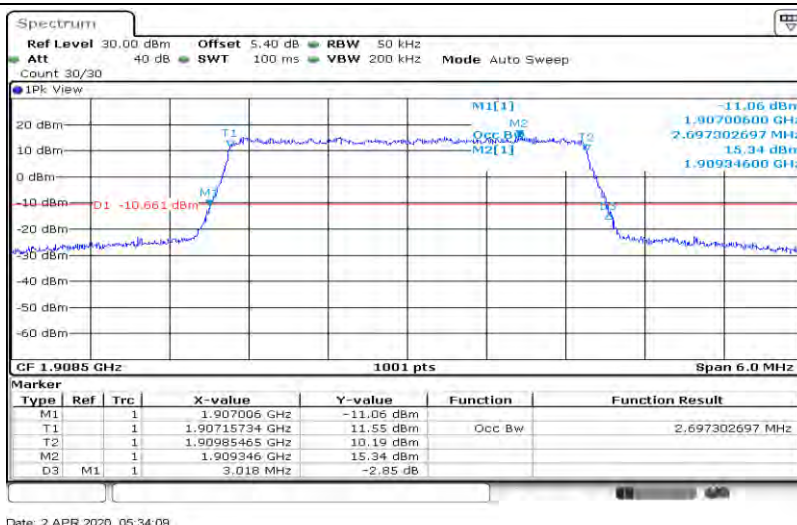


Band2-3MHz-QPSK-18900-15RB#0-2.697

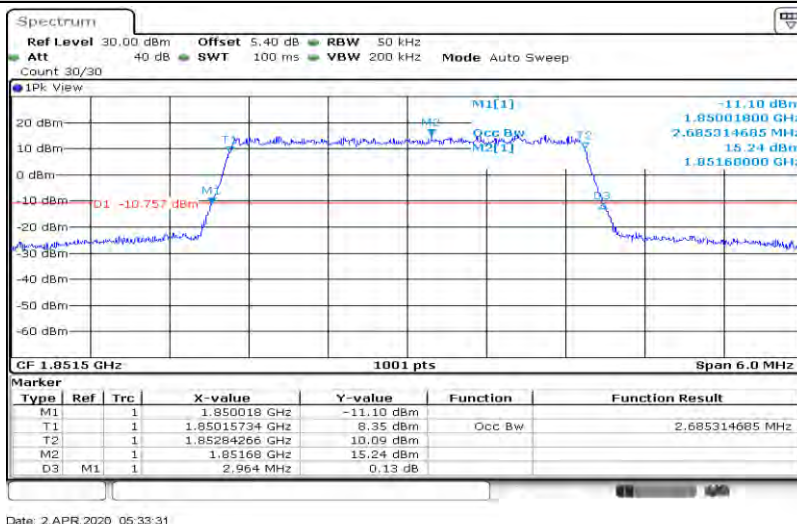


Band2-3MHz-QPSK-19185-15RB#0-2.697



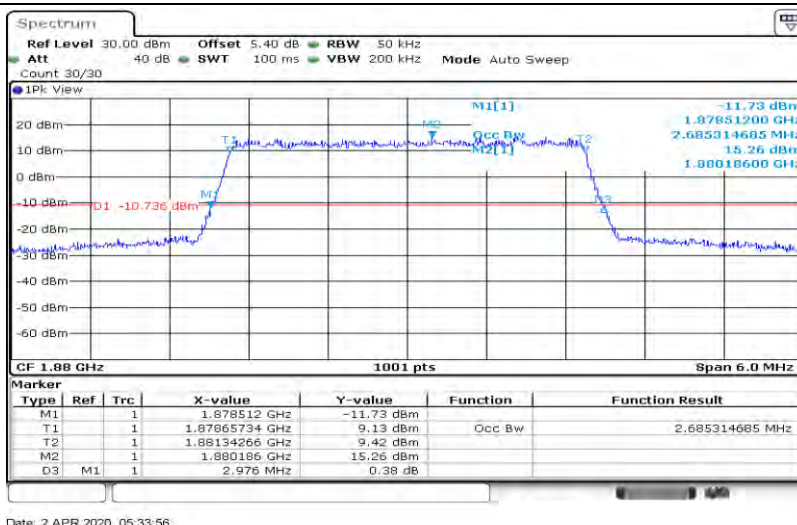


Band2-3MHz-16QAM-18615-15RB#0-2.685

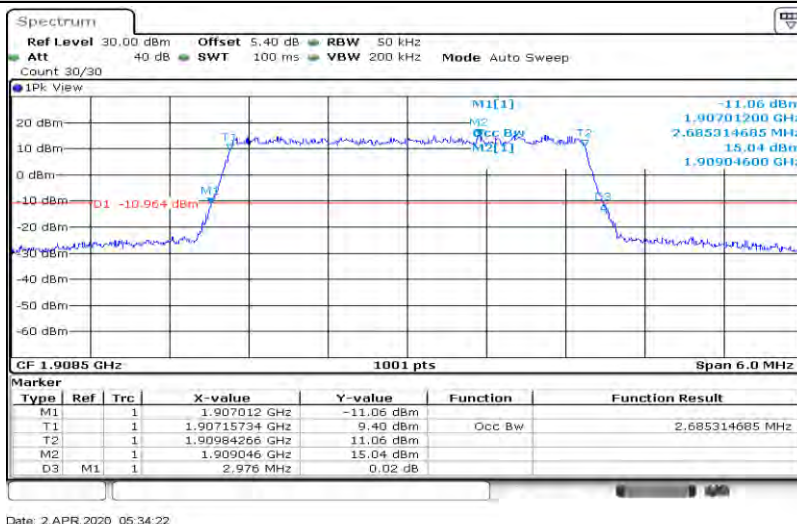

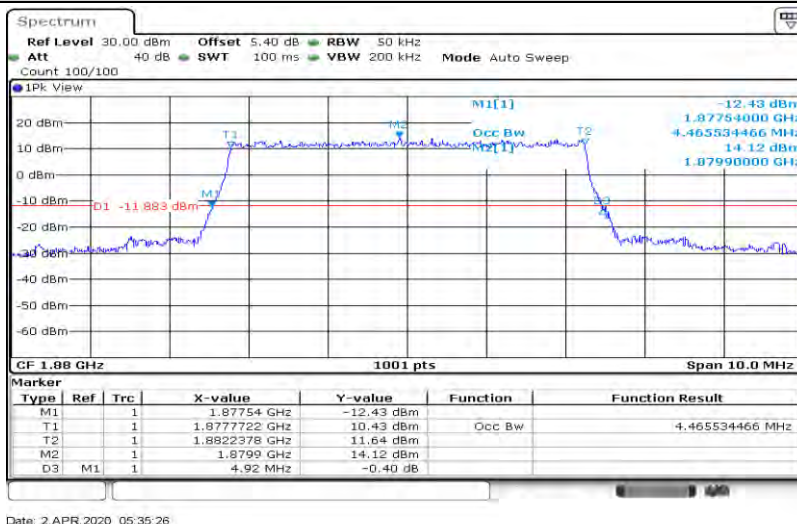


Band2-5MHz-QPSK-18625-25RB#0-4.476



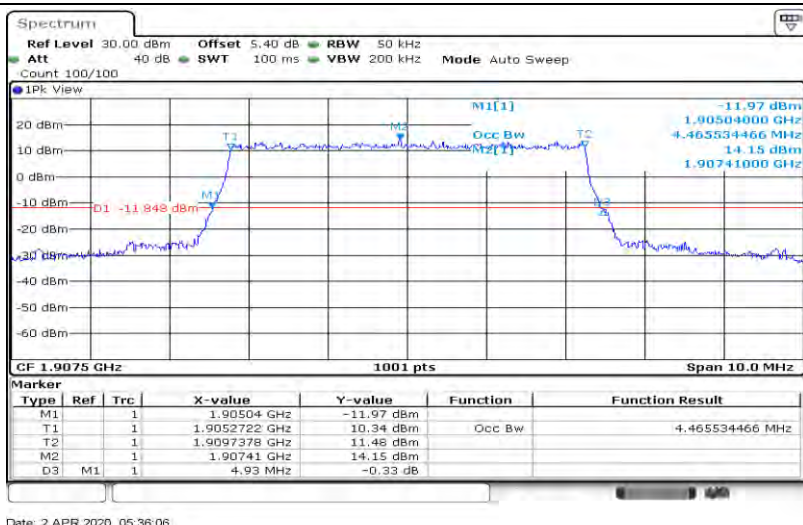


Band2-5MHz-QPSK-18900-25RB#0-4.466

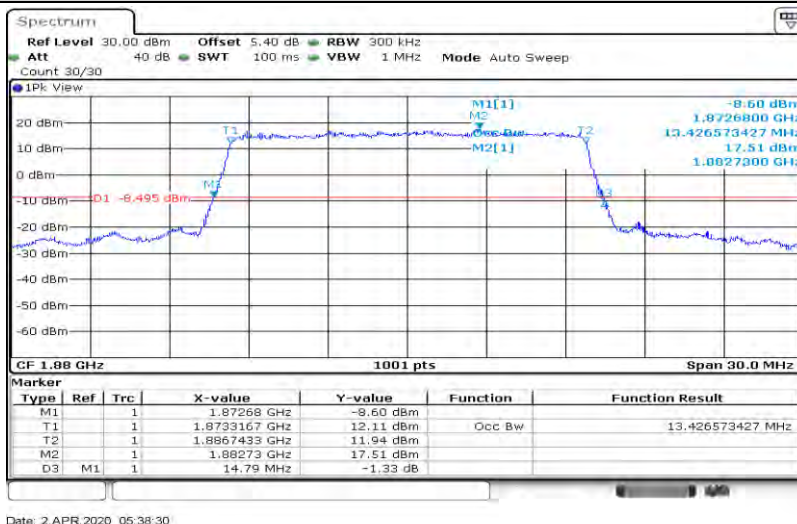


Band2-15MHz-QPSK-18675-75RB#0-13.427



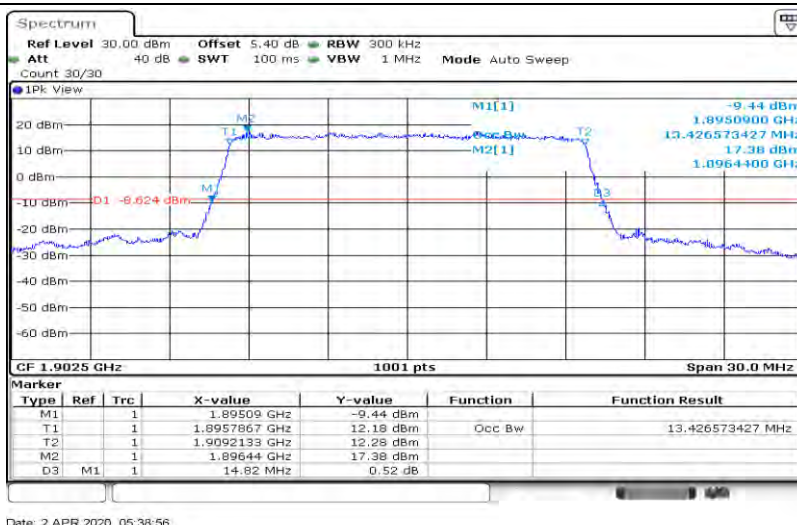

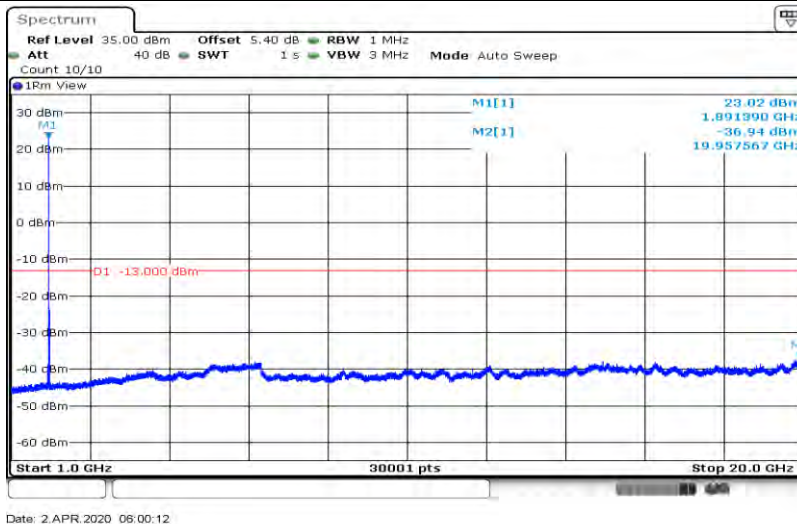


Band2-20MHz-QPSK-19100-1RB#0-Range1:30~1000MHz



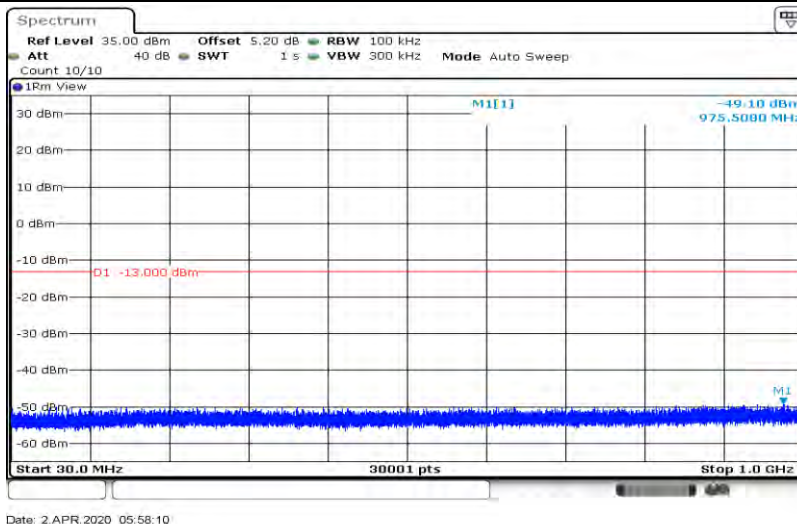

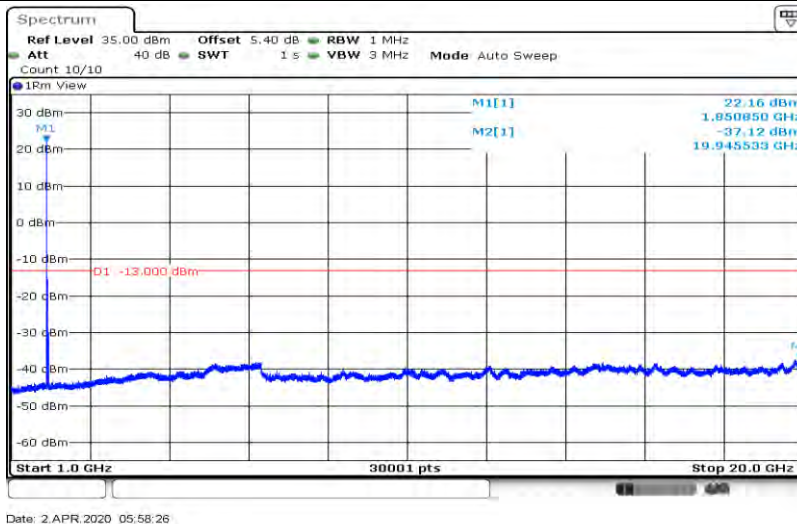


Band2-20MHz-16QAM-18700-1RB#0-Range1:30~1000MHz



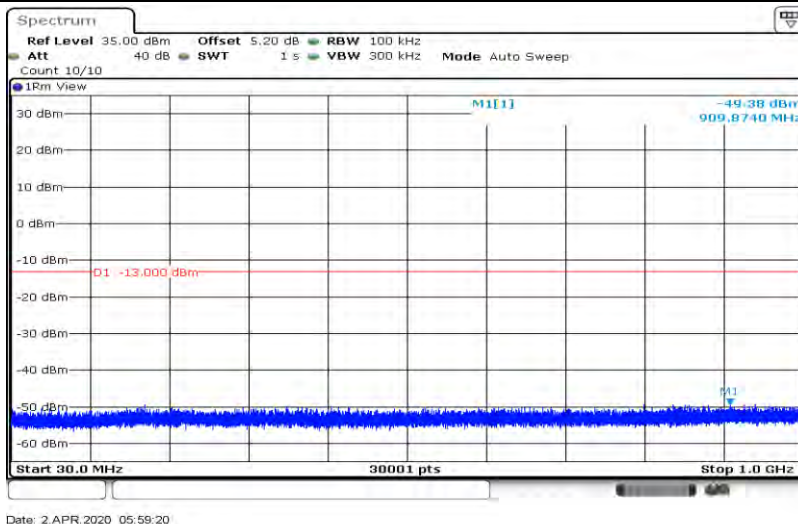


Band2-20MHz-16QAM-18700-1RB#0-Range2:1000~20000MHz

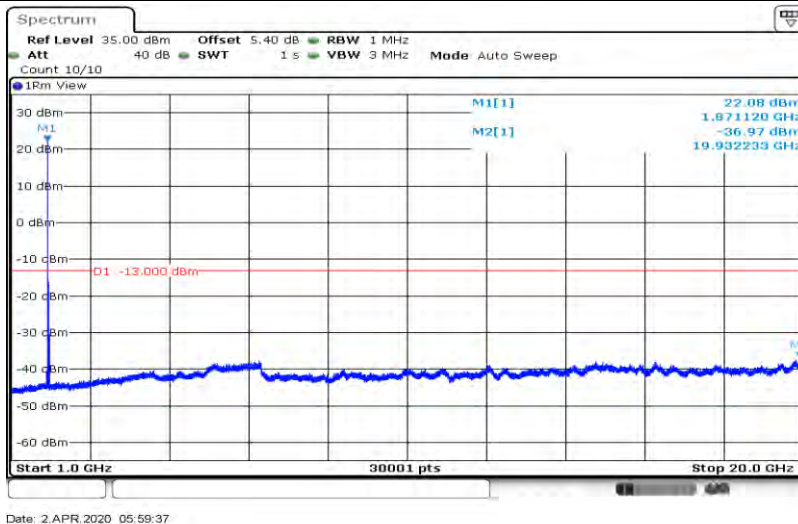

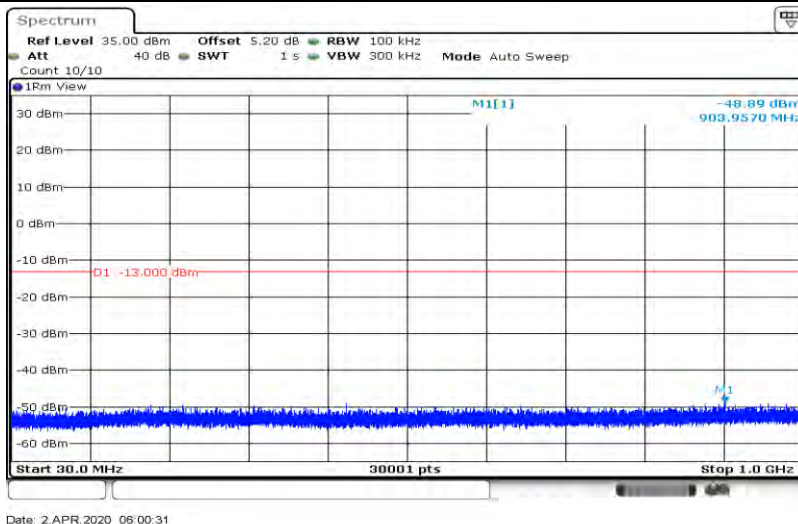

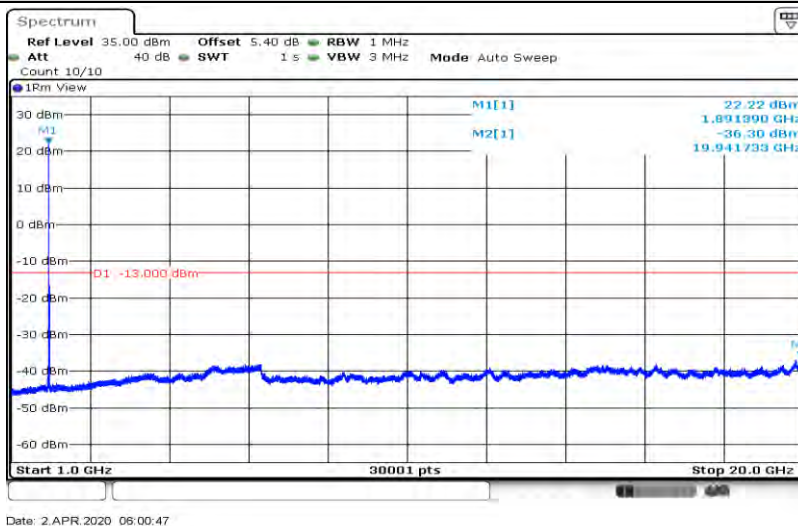
