### 3. TEST METHODOLOGY

The measurement procedure described in the American National Standard for Testing Unlicensed Wireless Devices(ANSI C63.4-2003) and FCC Public Notice DA 00-705 dated March 30, 2000 entitled “Filing and Measurement Guidelines for Frequency Hopping Spread Spectrum Systems” were used in the measurement of the **LG Electronics MobileComm U.S.A., Inc.**  
**Cellular/PCS GSM/GPRS/EDGE/WCDMA and LTE phone with Bluetooth, WLAN and RFID**  
**FCC ID: ZNFD956**

#### 3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements. According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

#### 3.3 GENERAL TEST PROCEDURES

##### Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4. (Version :2003) Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

##### Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3 m away from the receiving antenna, which varied from 1 m to 4 m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4. (Version: 2003). To record the final measurements, the analyzer detector function was set to CISPR quasi-peak mode and the bandwidth of the spectrum analyzer was set to 120 kHz for frequencies below 1 GHz or 1 MHz for frequencies above 1 GHz. For average measurements above 1 GHz, the analyzer was set to peak detector with a reduced VBW setting(RBW = 1 MHz, VBW = 1/T Hz, where T = Pulse width).

### 3.4 DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition. Test program used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

Channel low, mid and high with highest data rate (worst case) is chosen for full testing.

## 4. INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipments, which is traceable to recognized national standards.

## 5. FACILITIES AND ACCREDITATIONS

### 5.1 FACILITIES

The SAC(Semi-Anechoic Chamber) and conducted measurement facility used to collect the radiated data are located at the 74, Seoicheon-ro 578beon-gil, Majang-myeon, Icheon-si, Gyeonggi-do, Korea. The site is constructed in conformance with the requirements of ANSI C63.4. (Version :2003) and CISPR Publication 22. Detailed description of test facility was submitted to the Commission and accepted dated June 21, 2011 (Registration Number: 90661)

### 5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of Linearly polarized antennas: tuned dipole, bi-conical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements. Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers. Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

## 6. ANTENNA REQUIREMENTS

### According to FCC 47 CFR §15.203:

"An intentional radiator antenna shall be designed to ensure that no antenna other than that furnished by the responsible party can be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section."

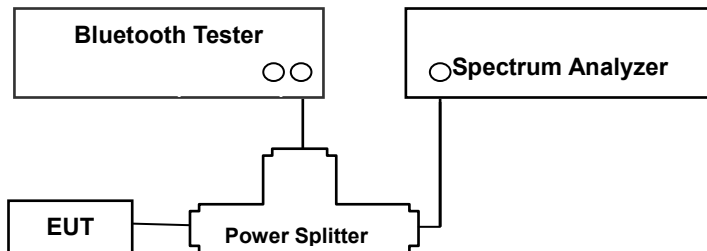
### 8.1 PEAK POWER

#### LIMIT

The maximum peak output power of the intentional radiator shall not exceed the following:

1. For frequency hopping systems operating in the 2400–2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725–5850 MHz band: 1 W for hopping mode, 125 mW for AFH mode
2. The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi.

#### TEST PROCEDURE

The transmitter output is connected to the Spectrum Analyzer. The Spectrum Analyzer is set to the peak detector mode. This test is performed with hopping off.

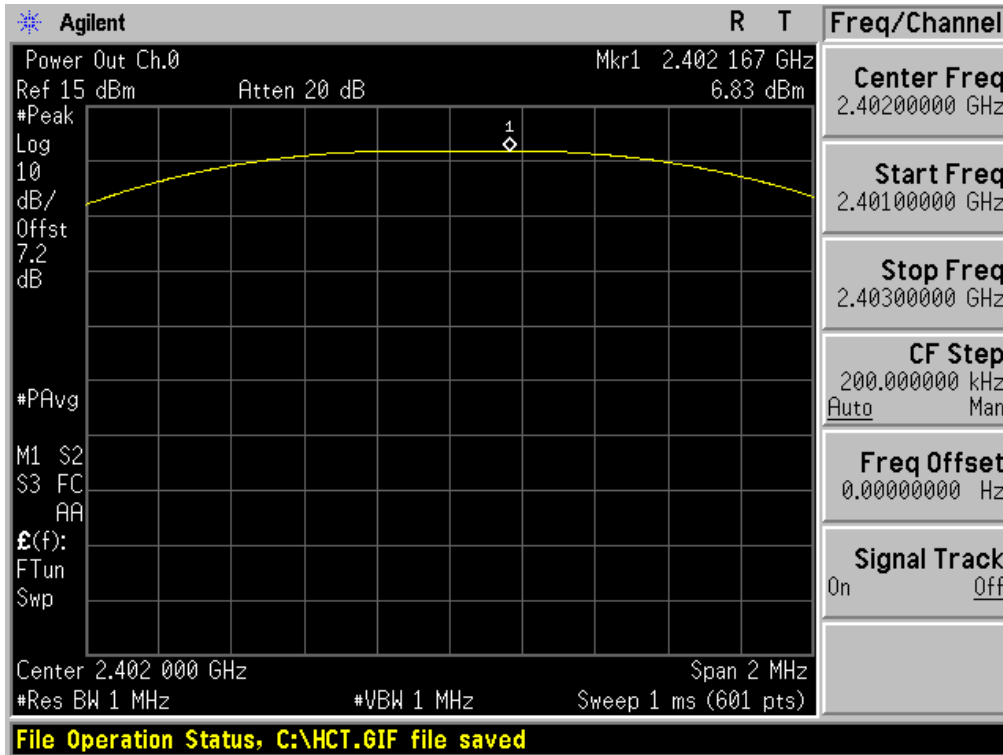

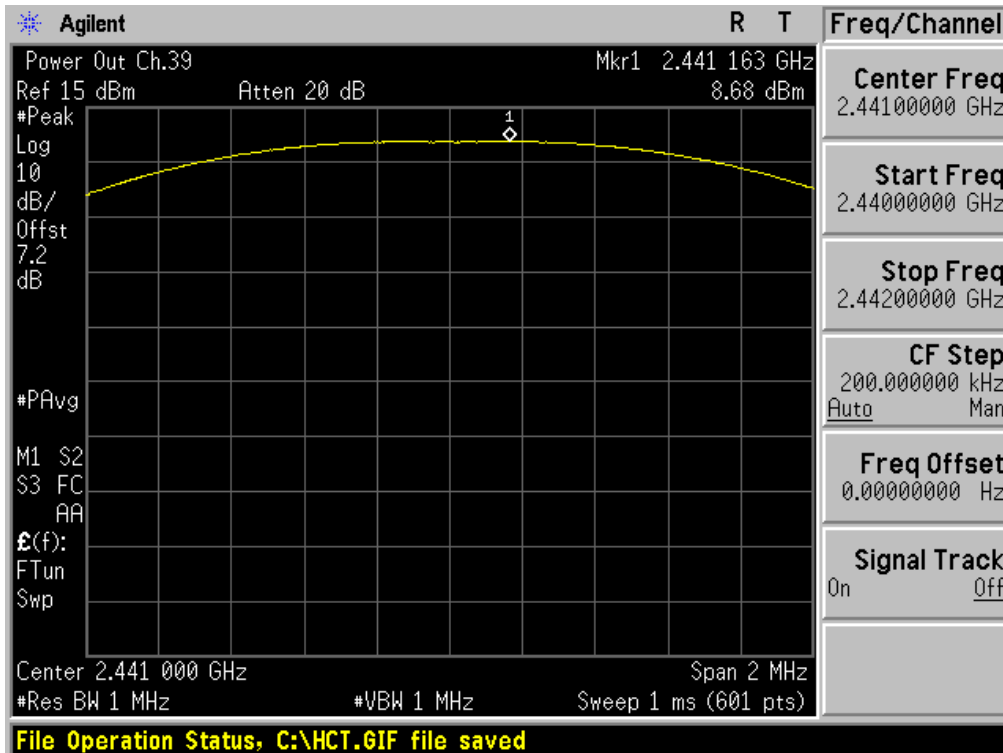

Peak Power (Low-CH)



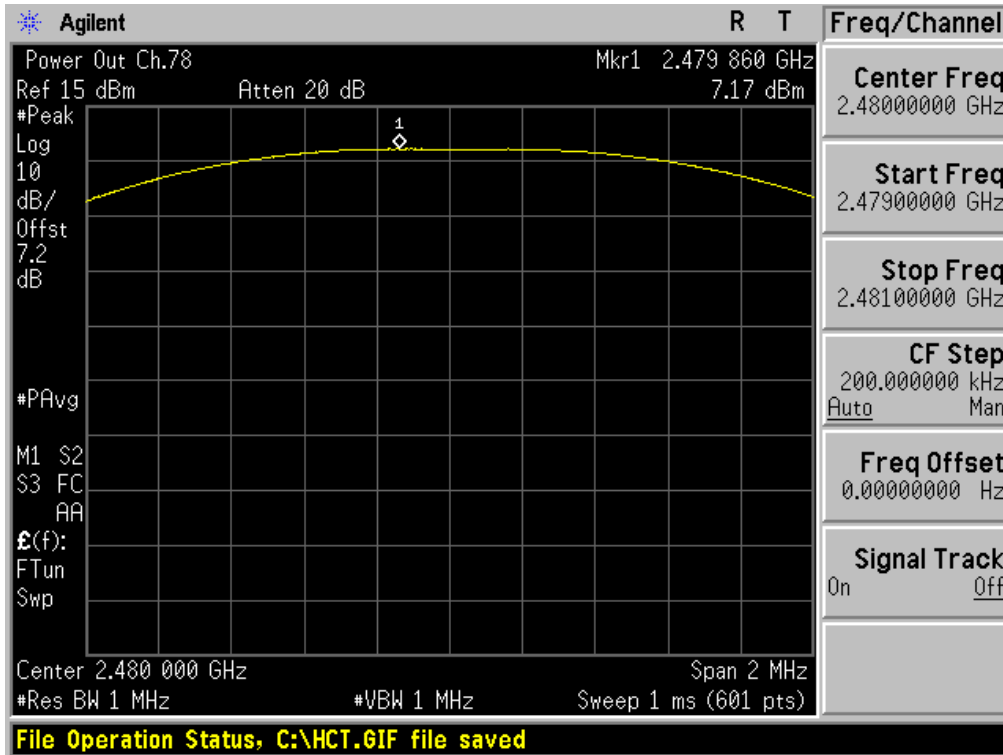
Test Plots (GFSK)  
Peak Power (Mid-CH)



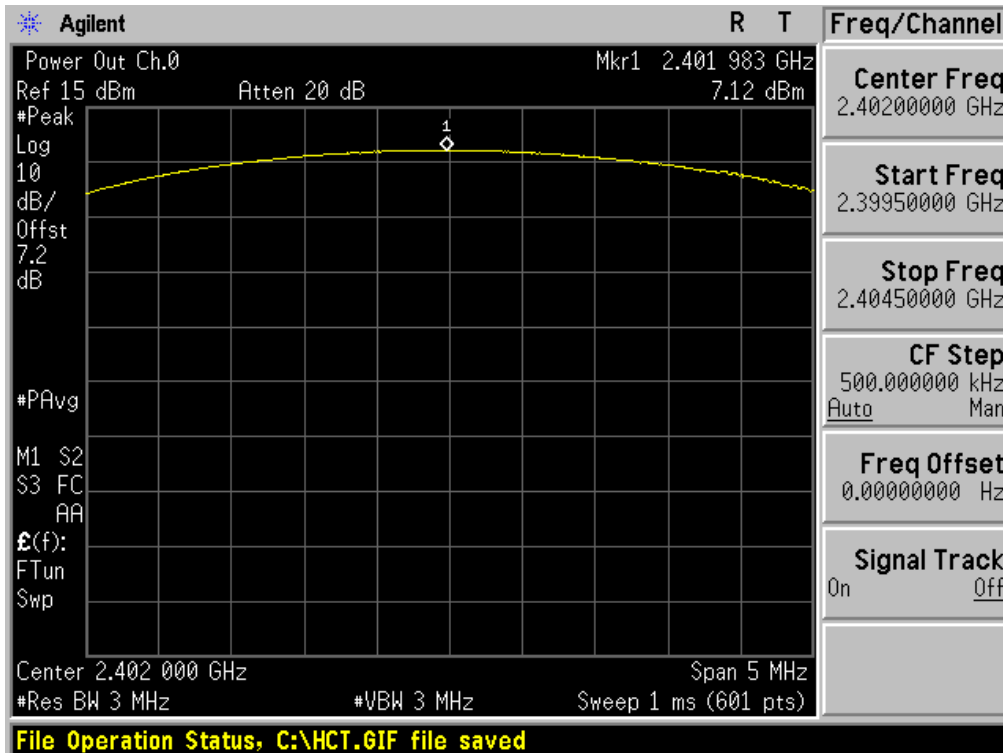

Peak Power (High-CH)



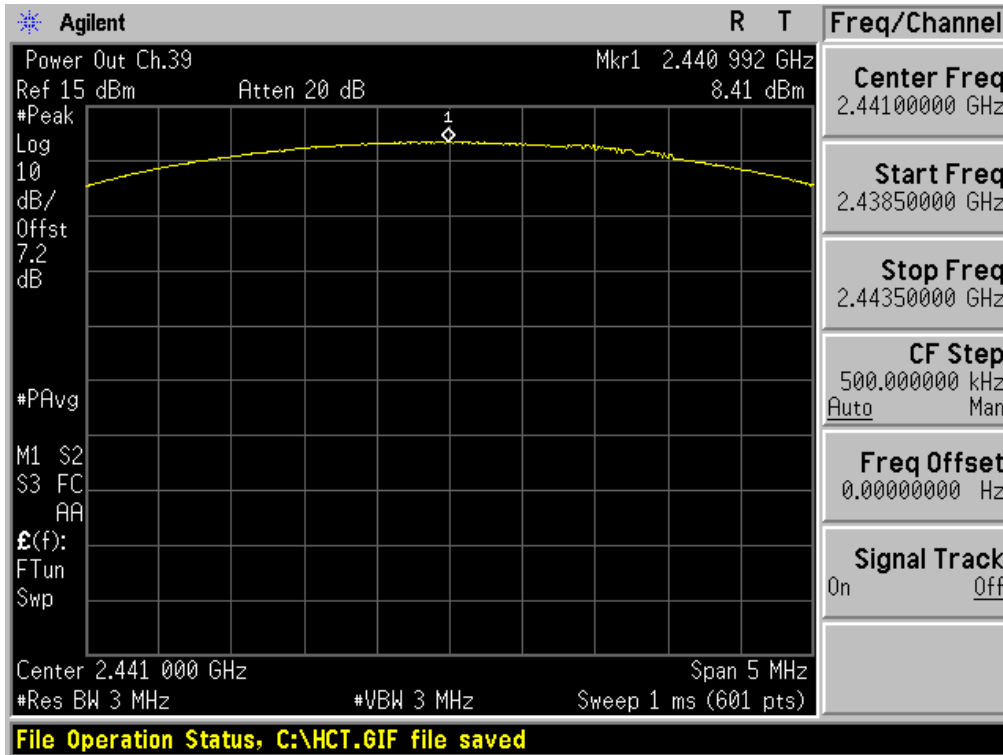
Test Plots (8DPSK)  
Peak Power (Low-CH)



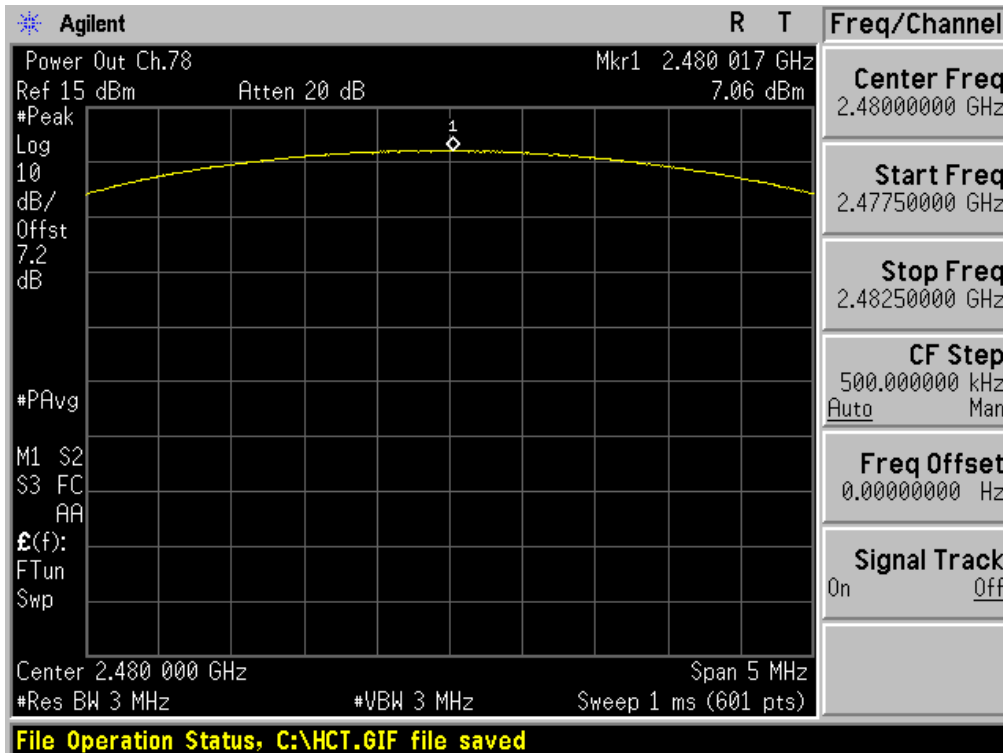

Peak Power (Mid-CH)

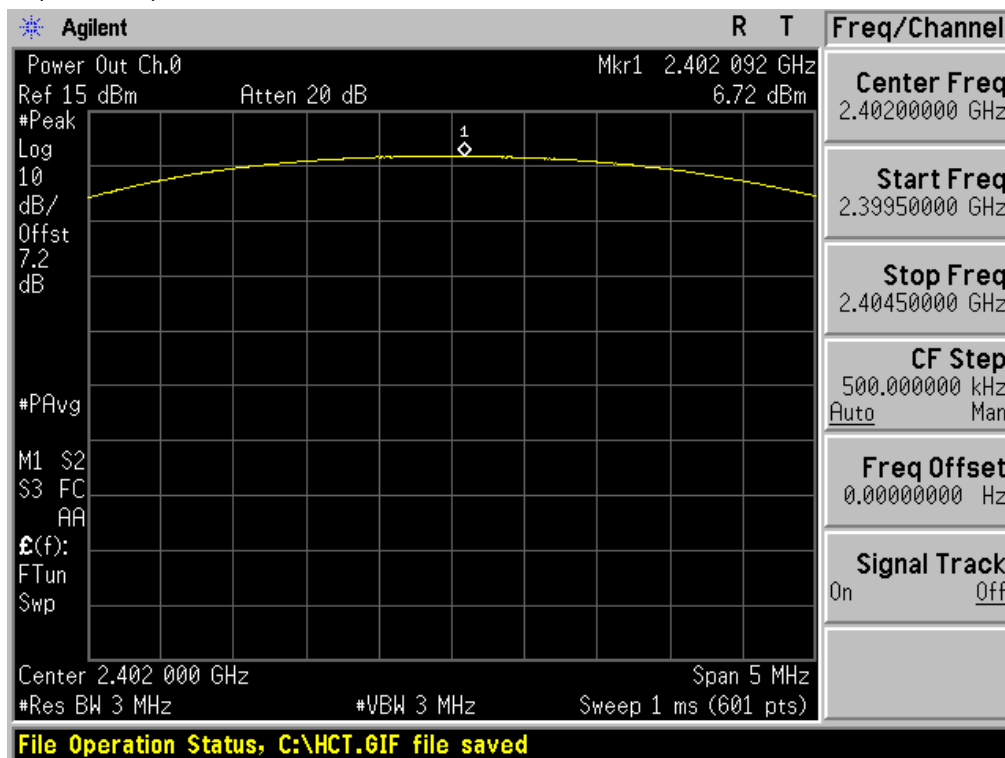


Test Plots (8DPSK)  
Peak Power (High-CH)

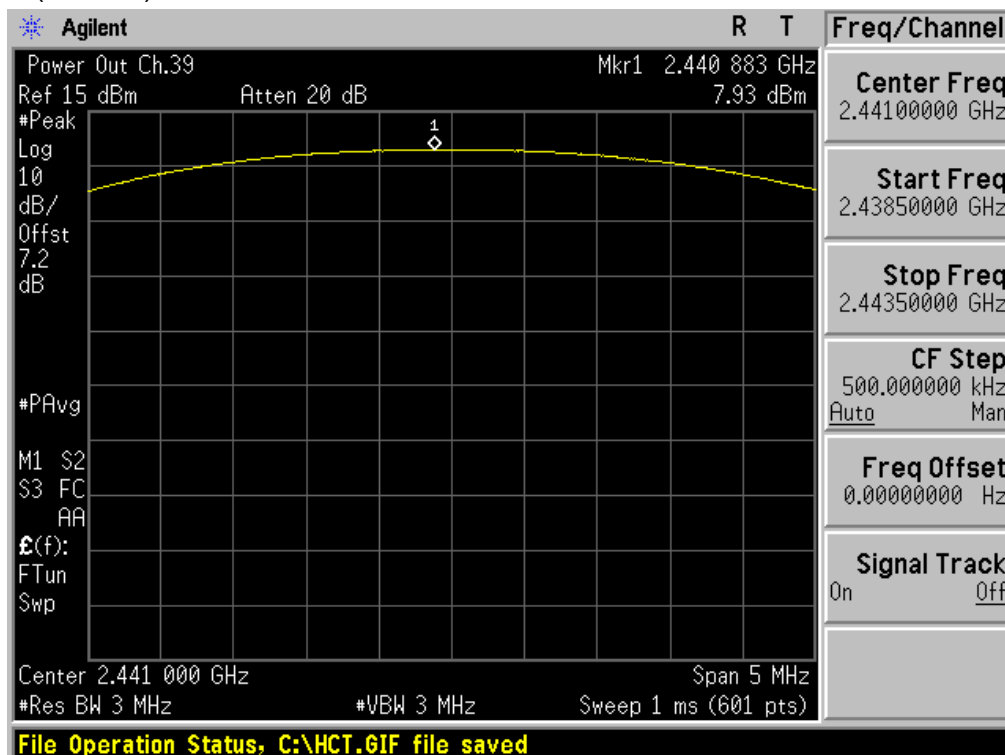

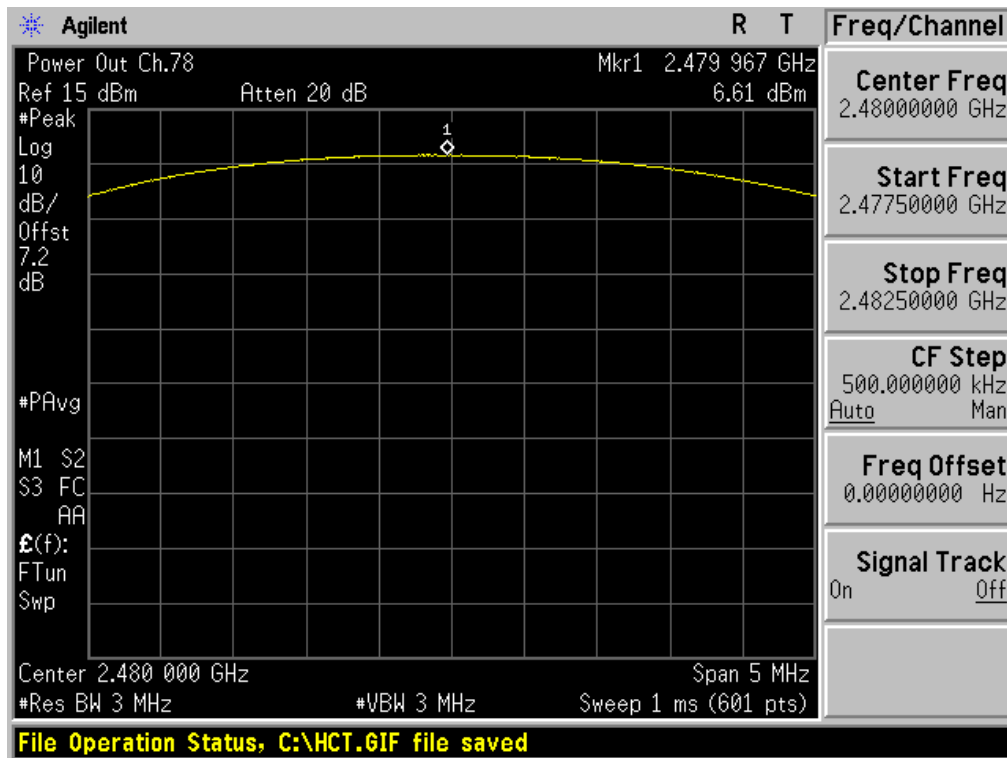
Test Plots ( $\pi/4$ DQPSK)

Peak Power (High-CH)

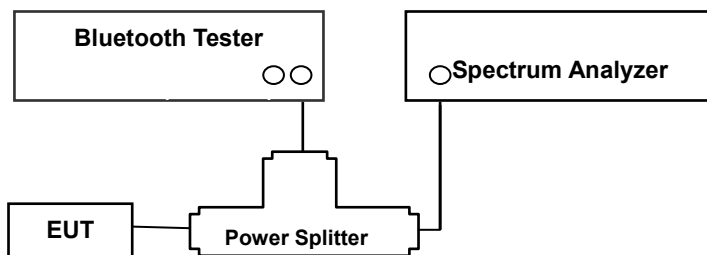


## 8.2 BAND EDGES

### LIMIT

According to §15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits.

Number of Channels (2.4 GHz - 2.441 GHz)



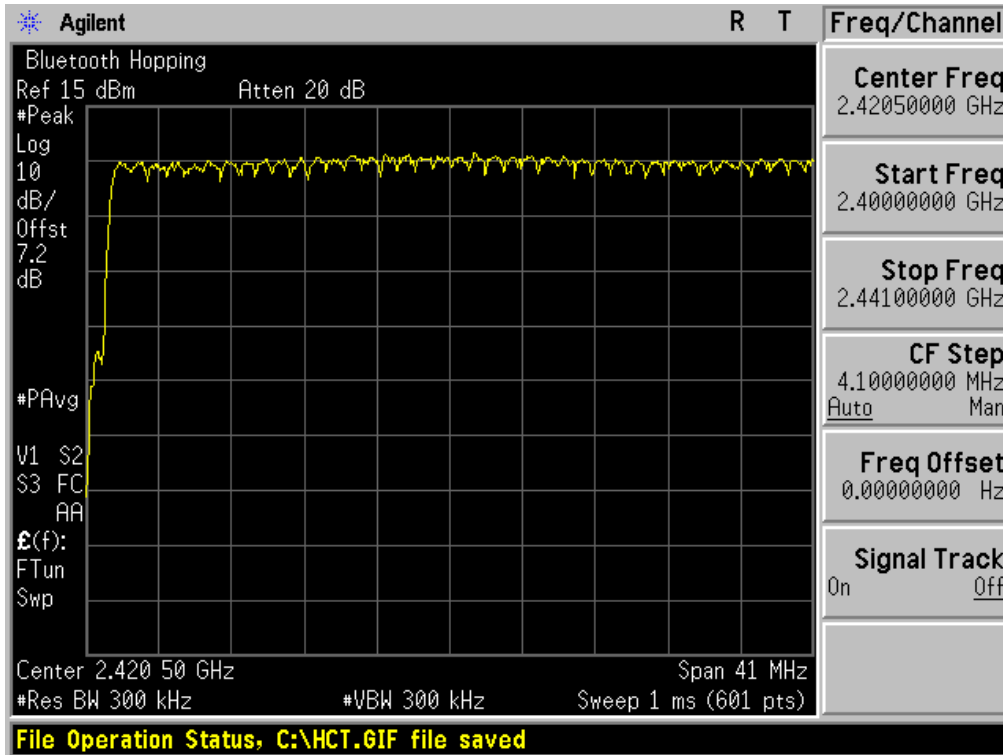

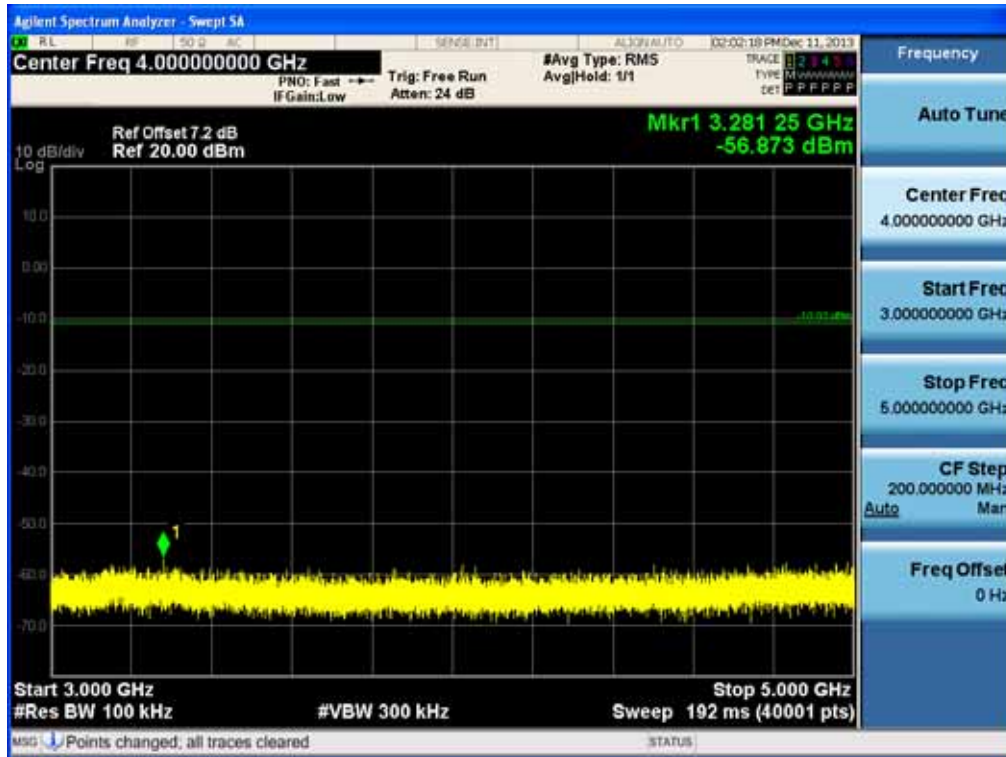

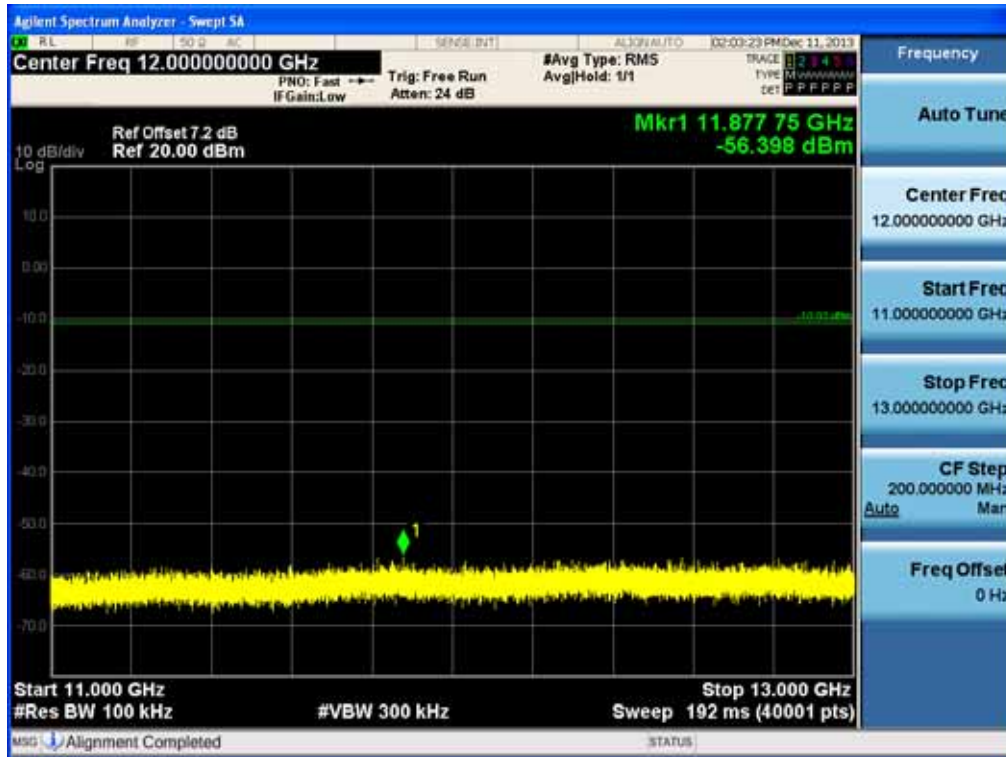

### 8.6.3 RADIATED RESTRICTED BAND EDGES

#### Test Requirements and limit, §15.247(d), §15.205, §15.209

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in section 15.209(a) (See section 15.205(c)).

  - AV Setting 1 GHz – 26 GHz, RBW = 1 MHz, VBW = 1 kHz  $\geq 1/\tau$  Hz, where  $\tau$  = pulse width in seconds.  
We performed using a reduced video BW method was done with the analyzer in linear mode.
- FYI : Duty Cycle Correction Factor (79 channel hopping)
  - Time to cycle through all channels=  $\Delta t = \tau$  [ms] x 79 channels = 228.468 ms, where  $\tau$  = pulse width
  - $100 \text{ ms} / \Delta t$  [ms] =  $H \rightarrow$  Round up to next highest integer,  $H' = 1$
  - Worst Case Dwell Time =  $\tau$  [ms] x  $H' = 2.892$  ms
  - Duty Cycle Correction =  $20\log(\text{Worst Case Dwell Time} / 100\text{ms})$  dB = -30.776 dB
- Duty Cycle Correction Factor(AFH mode – minimum channel number case - 20 channels)
  - Time to cycle through all channels=  $\Delta t = \tau$  [ms] x 20 channels = 57.84 ms, where  $\tau$  = pulse width
  - $100 \text{ ms} / \Delta t$  [ms] =  $H \rightarrow$  Round up to next highest integer,  $H' = 2$
  - Worst Case Dwell Time =  $\tau$  [ms] x  $H' = 5.784$  ms
  - Duty Cycle Correction(AFH) =  $20\log(\text{Worst Case Dwell Time} / 100\text{ms})$  dB = -24.7554 dB
  - We applied DCCF in the test result which hopping channel number is 20.
- We have done Normal Mode, EDR Mode.
- This test is performed with hopping off.
- We have done x, y, z planes in EUT and horizontal and vertical polarization in detecting antenna.

## 8.7 POWERLINE CONDUCTED EMISSIONS

### LIMIT

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolt (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range is listed as follows:

Compliance with this provision shall be based on the measurement of the radio frequency voltage between each power line (LINE and NEUTRAL) and ground at the power terminals.

### TEST PROCEDURE

1. The EUT is placed on a wooden table 80 cm above the reference ground plane.
2. The EUT is connected via LISN to a test power supply.
3. The measurement results are obtained as described below:
4. Detectors – Quasi Peak and Average Detector.
5. This test is performed with hopping off and 1 Mbps (DH5) data rate of No.39 channel.

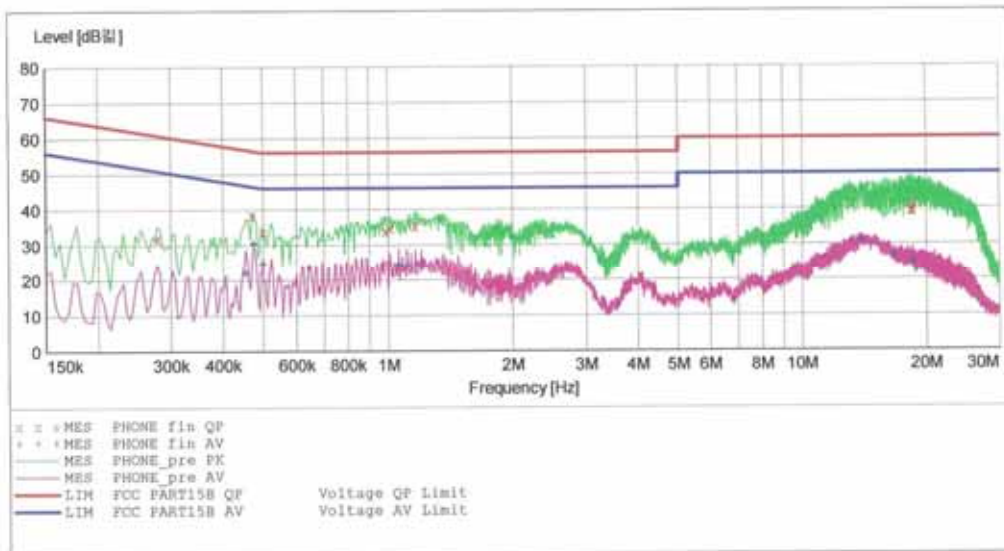

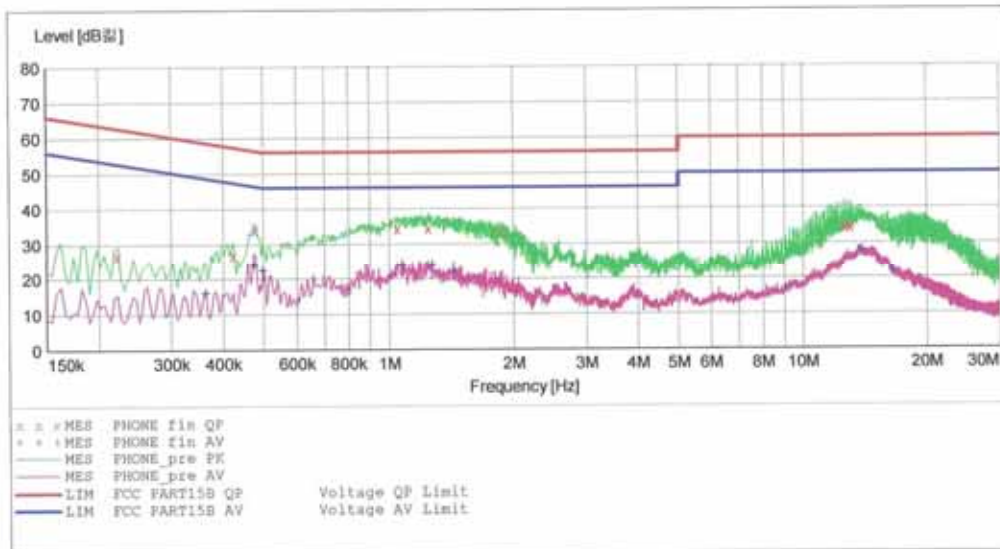
