### 4.2.2 Conclusion

Standard Requirement:

The system shall hop to channel frequencies that are selected at the system hopping rate from a Pseudorandom ordered list of hopping frequencies. 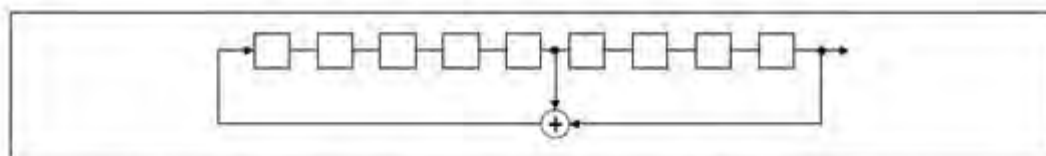

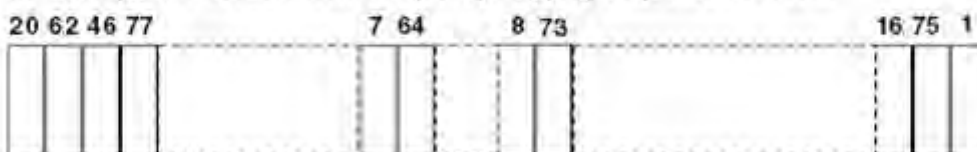
Linear Feedback Shift Register for Generation of the PRBS sequence

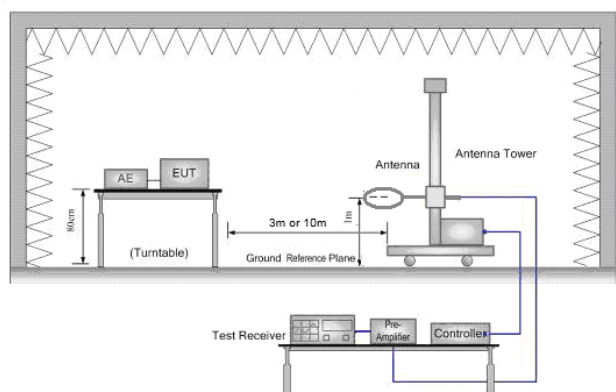


Figure 1. Below 30MHz

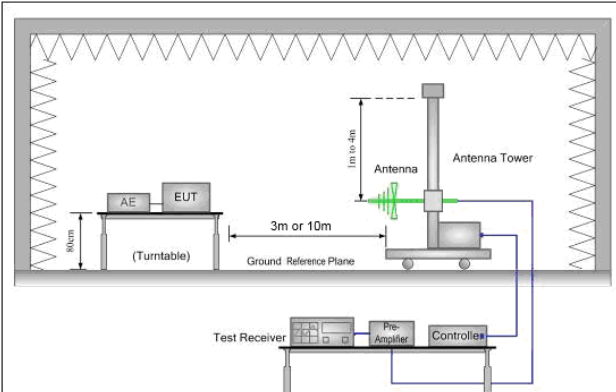


Figure 2. 30MHz to 1GHz

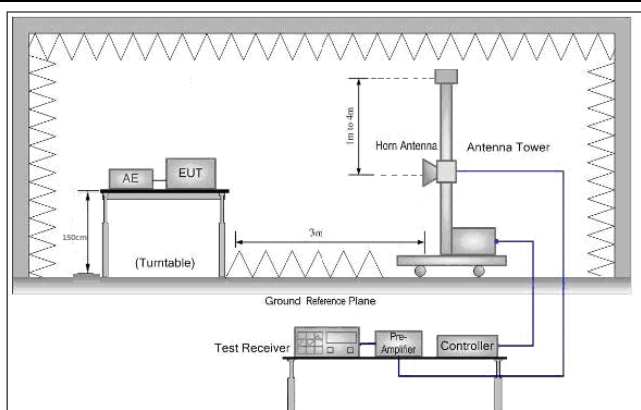


Figure 3. Above 1 GHz

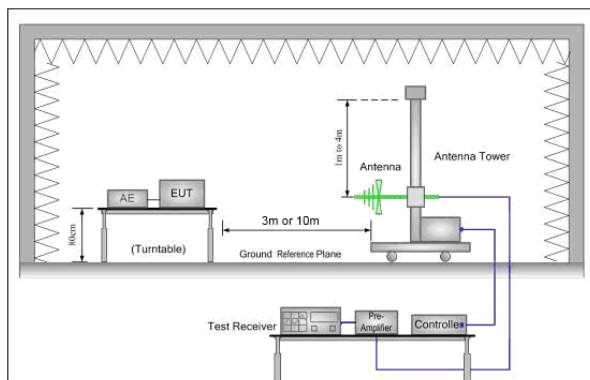


Figure 1. 30MHz to 1GHz

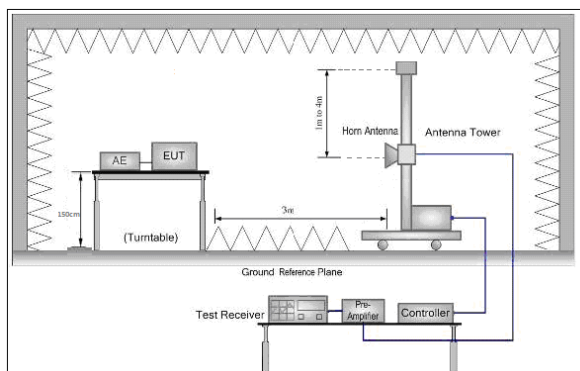


Figure 2. Above 1 GHz
