





Plot 7-87. Radiated Upper Band Edge Plot (Average – UNII Band 2A)




Plot 7-88. Radiated Upper Band Edge Plot (Peak – UNII Band 2A)


Plot 7-89. Radiated Upper Band Edge Plot (Average – UNII Band 2A)




Plot 7-90. Radiated Upper Band Edge Plot (Peak – UNII Band 2A)




Plot 7-91. Radiated Lower Band Edge Plot (Average – UNII Band 2C)




Plot 7-92. Radiated Lower Band Edge Plot (Peak – UNII Band 2C)


Plot 7-93. Radiated Lower Band Edge Plot (Average – UNII Band 2C)



Plot 7-94. Radiated Lower Band Edge Plot (Peak – UNII Band 2C)






Plot 7-96. Radiated Upper Band Edge Plot (Peak – UNII Band 2C)



Plot 7-97. Radiated Lower Band Edge Plot (Peak – UNII Band 3)




Plot 7-98. Radiated Upper Band Edge Plot (Peak – UNII Band 3)






Plot 7-99. Radiated Lower Band Edge Plot (Average – UNII Band 1)




Plot 7-100. Radiated Lower Band Edge Plot (Peak – UNII Band 1)

Plot 7-101. Radiated Upper Band Edge Plot (Average – UNII Band 2A)




Plot 7-102. Radiated Upper Band Edge Plot (Peak – UNII Band 2A)




Plot 7-103. Radiated Lower Band Edge Plot (Average – UNII Band 2C)




Plot 7-105. Radiated Upper Band Edge Plot (Peak – UNII Band 2C)



Plot 7-106. Radiated Lower Band Edge Plot (Peak – UNII Band 3)




Plot 7-107. Radiated Upper Band Edge Plot (Peak – UNII Band 3)






Plot 7-108. Radiated Lower Band Edge Plot (Average – UNII Band 1)




Plot 7-109. Radiated Lower Band Edge Plot (Peak – UNII Band 1)


Plot 7-110. Radiated Upper Band Edge Plot (Average – UNII Band 2A)




Plot 7-111. Radiated Upper Band Edge Plot (Peak – UNII Band 2A)


Plot 7-112. Radiated Lower Band Edge Plot (Average – UNII Band 2C)




Plot 7-113. Radiated Lower Band Edge Plot (Peak – UNII Band 2C)




Figure 7-6. Radiated Test Setup < 30MHz




Figure 7-7. Radiated Test Setup < 1GHz







Figure 7-8. Test Instrument & Measurement Setup






Plot 7-117. Line Conducted Plot with 802.11a UNII Band 1 (L1)




Plot 7-118. Line Conducted Plot with 802.11a UNII Band 1 (N)




Plot 7-119. Line Conducted Plot with 802.11a UNII Band 2A (L1)




Plot 7-120. Line Conducted Plot with 802.11a UNII Band 2A (N)




Plot 7-121. Line Conducted Plot with 802.11a UNII Band 2C (L1)




Plot 7-122. Line Conducted Plot with 802.11a UNII Band 2C (N)
