Request to waiver of Rules 47 CFR sections 1.925(b)(2) and (3) for MSLD „EasyONE“

Dear Sir,

Weatherdock AG (FRN : 0020869210) hereby requests a waiver of Rules 47 CFR sections 1.925(b)(2) and (3) of the Federal Communications Commission's to permit usage and distribution of the marine survivor locating device „easyONE“. The easyONE is an AIS-MOB MSLD device which can easily be integrated to any lifevest and is therefore ideal for upgrading existing lifevests with a MSLD.

Background:

We have been instructed by email dated May 13th 2019 from Tim Maguire, Wireless Telecommunication Bureau, Federal Communication Commission to apply for a waiver, if the device complies to a later version of the standard 11901.1, Amendment 1 dated May 2, 2014, which is the case. The conformity to the rules and standards has been certified by TUV SUD Oc. 70464-37519-01 (Ed. 1) on 6th March 2014 and the compliance to requirements 47 CFR Part 95 and RTCM Standard 11901.1 as an alerting unit has been stated by USCG, document 16714/PLB-MSLD, reference ID#:2018-3611 on 2nd April 2019. In this document, USCG states also to have no objection to continuing the process for acceptance with the U.S. Federal Communications Commission.

Therefore we request that the Commission waive its rules 47 CFR sections 1.925(b)(2) and (3) to permit usage and distribution of the MSLD device „easyONE“.
