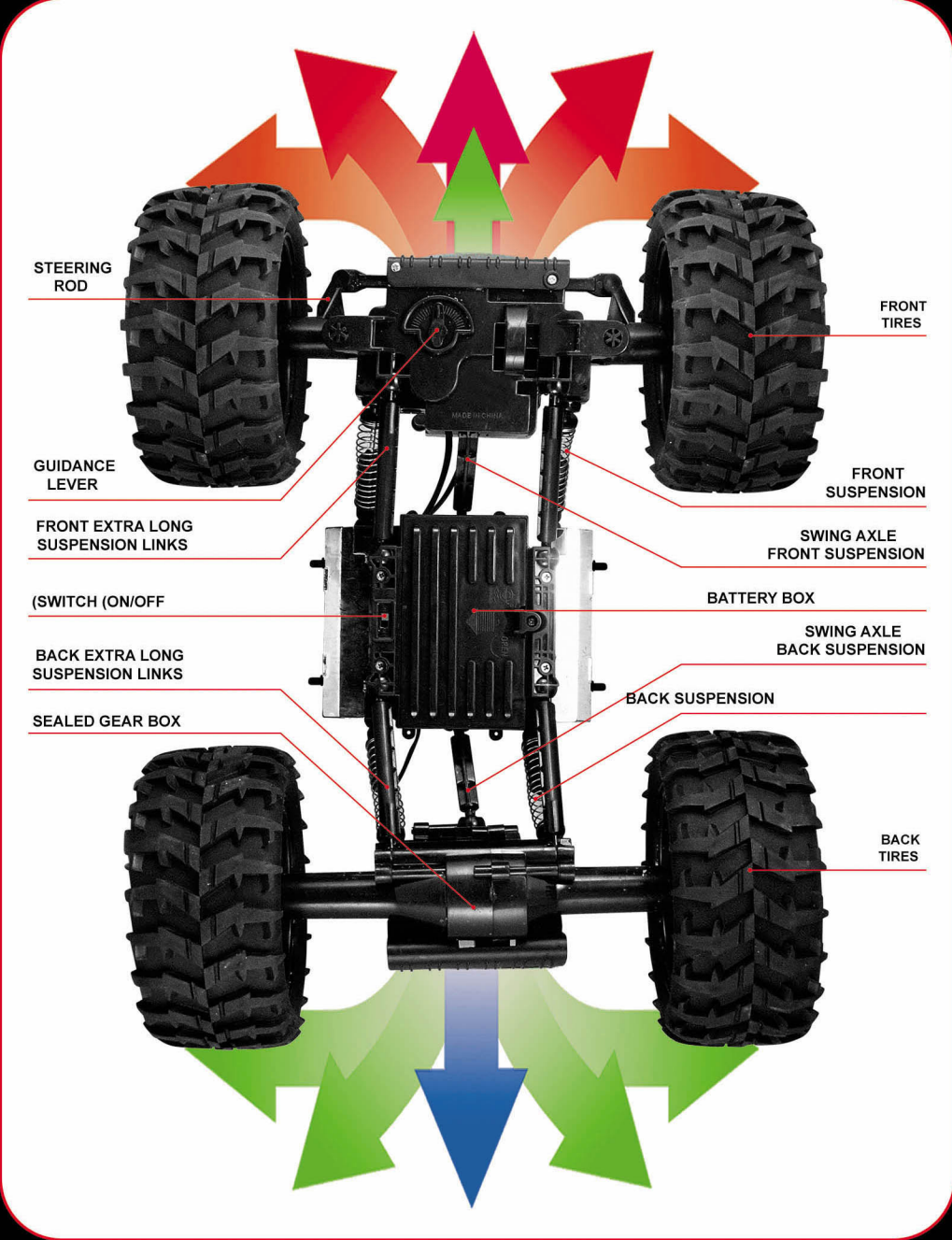


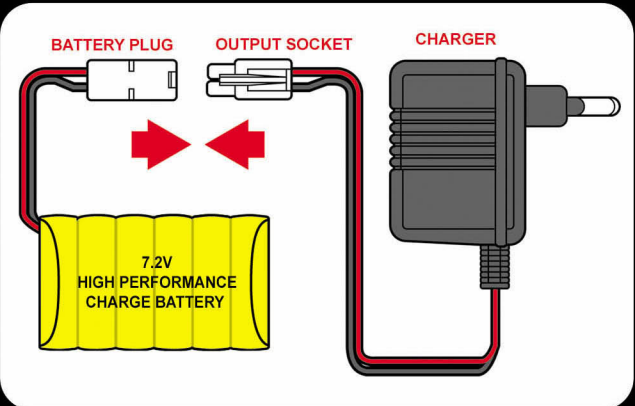
BATTERY INSTALLATION



HOW TO RECHARGE THE BATTERY:

CHARGE THE 7.2V BATTERY BEFORE USING. FOLLOW THE INSTRUCTIONS. ADULT SUPERVISION REQUIRED WHEN CHARGING BATTERIES.

- To recharge the battery, insert the plug charger with an indoor power jack. Please use the same voltage.
- Battery charging time is 4-6 hours.
- Separate the charger from the battery once you have finished charging it.



HOW TO REMOVE AND INSERT REPLACEABLE BATTERIES (Diagram and Instructions)

Non-rechargeable batteries are not to be recharged
Rechargeable batteries are to be removed from the toys before being charged
Rechargeable batteries are only to be charged under adult supervision
Different types of batteries or new and used batteries should not be mixed
Only batteries of the same or equivalent type as recommended are to be used
Batteries are to be inserted with the correct polarity
Exhausted batteries are to be removed from the toy
The supply terminals are not to be short-circuited

BATTERY SAFETY INFORMATION

- Insure that battery polarity is correct.
- Use only batteries of the type recommended (or equivalent).
- Do not mix old and new batteries.
- Do not mix alkaline, standard (carbon-zinc), or rechargeable (nickel-cadmium) batteries.
- Rechargeable batteries are to be removed from the product before being charged.
- Rechargeable batteries are to be recharged by Adult only.
- Remove used-up batteries immediately.
- Do not recharge non-rechargeable batteries.
- Do not short-circuit terminals.
- Dispose of batteries safely. Do not dispose of batteries (or products containing non-rechargeable batteries) in fire, as batteries may explode or leak.
