FACTSHEET

1. INTRODUCTION

- 1.1 TÜV SÜD PSB PTE LTD is a designated Telecommunications Certification Body ("TCB") and is able to issue Grant of Equipment Authorization ("Grant") for products tested to comply with the Federal Communications Commission (FCC) requirements. The TCB-FCC Certification Scheme ("TCB-FCC") is operated by TUV SUD PSB to enable companies to apply for certification of products by obtaining the Grant.
- 1.2 These Terms and Conditions are applicable to all companies who apply to have their products certified under the TCB-FCC Scheme.
- 1.3 All products to be certified in the scheme shall bear the company's name/trademark and brand name on every product for identification purposes.
- 1.4 The information in the Grant may be used as a means for benchmarking of product performance. The confidentiality of the company's information will be kept.

2. APPLICATION

- 2.1 A company may apply for certification under the TCB-FCC scheme if a representative sample of the product to be certified has been type-tested in accordance with clause 3 and has been found to be in compliance with FCC requirements.
- 2.2 Application forms can be obtained from TÜV SÜD PSB Certification Department (CRT). The company shall complete and return the application form, together with the most recent test report, design and material specifications, and any other relevant supporting documents required under TCB-FCC Scheme to:

- 2.3 The company represents and warrants that all information contained in the application form and the supporting documents are true, complete and accurate.
- 2.4 TÜV SÜD PSB reserves the right to terminate the processing of application due to incomplete or insufficient information in the application form and/or the lack of the supporting documents.
- 2.5 The company shall ensure that it is capable of manufacturing products that conform to the relevant standard.

3. TYPE TESTING

- 3.1 Sampling of the product for testing shall be made from production lots representative of the company's or the manufacturer's production processes and shall be in a condition normally offered for sale.
- 3.2 The sampled product shall be subjected to a full type test according to the relevant FCC standard as required. The full type test shall be conducted by TÜV SÜD PSB or other test laboratories that had been evaluated and approved according to regulations of the FCC Commission for the purpose of the scheme.

4. CERTIFICATION

If the tested product is found to be in compliance to the relevant standard, a Grant stating compliance of the product to the relevant standard will be issued by TÜV SÜD PSB. The company will be notified of the issuance of the grant.

- a. The Grant does not bear any expiry date, so renewal of the Grant is not necessary.
- b. TÜV SÜD PSB, or FCC, reserves the right to revoke the Grant for any reason.
- c. Any Grant which revoked shall be considered cancelled and shall not be used by the company in any way whatsoever
- d. Supply or use of the product may be regulated in different countries. The award of the Grant does not indicate or imply in any way that the product would be approved for supply or use in each country. The Applicant is advised to seek approval from the relevant authorities, where applicable, before supplying or using the product.

5. POST CERTIFICATION

- 4.1 All certified products will be listed on the website of FCC (www.fcc.gov), which is available to the public.
- 4.1 Post-market surveillance will be conducted on certified products at a frequency per-determined by TÜV SÜD PSB.
- 4.2 During the validity of the certification, the company shall immediately inform TÜV SÜD PSB in writing on any of the following:
 - (a) Any changes to the name and/or address of the company;
 - (b) Any changes to the design & construction of the certified product;
 - (c) Any changes in circumstances or revision of the supporting documents submitted to TÜV SÜD PSB that will render the information to be no longer true, complete or accurate.
- 4.3 If additional testing is required due to any of the above changes, the company shall bear any required fee that will be incurred.

6. Complaints to Suppliers/ Applicant's Company

The Certification Body (TÜV SÜD PSB) shall require the supplier of the products to:

- a) Keep a record of all complaints made know to the supplier relating to a product's compliance with requirements of the relevant standards and to make these records available to the certification body when requested;
- b) Take appropriate action with respect to such complaints and any deficiencies found in products or services that affect compliances with requirements for certification;
- c) Documentation the action taken.
